

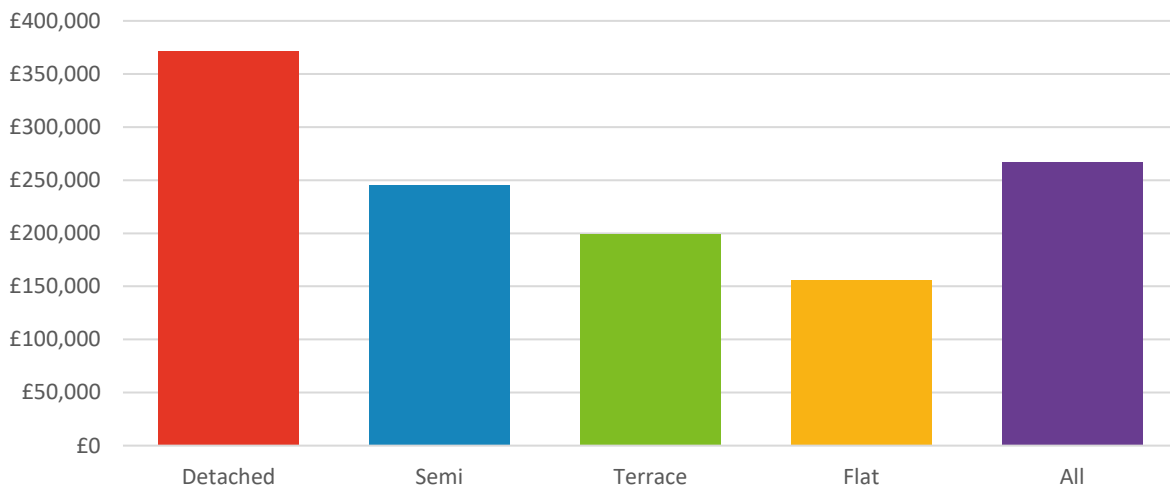

# 1. Affordability

Average house prices

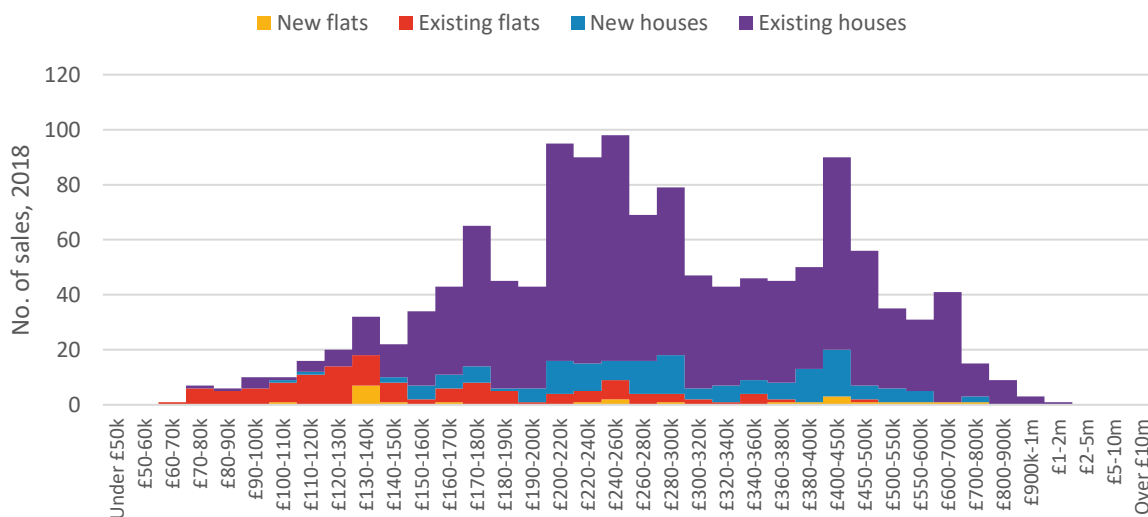

The average house price in Malvern Hills in 2018 was £267,000. The median ratio of house prices to local earnings is 9.8. This is higher than the England average of 8.0, suggesting high house prices are likely to be an issue.

According to 2016 ONS data, the average price per square metre was £2,313 with the average price per bedroom £57,920 - the corresponding national average figures were £2,463 and £55,087.

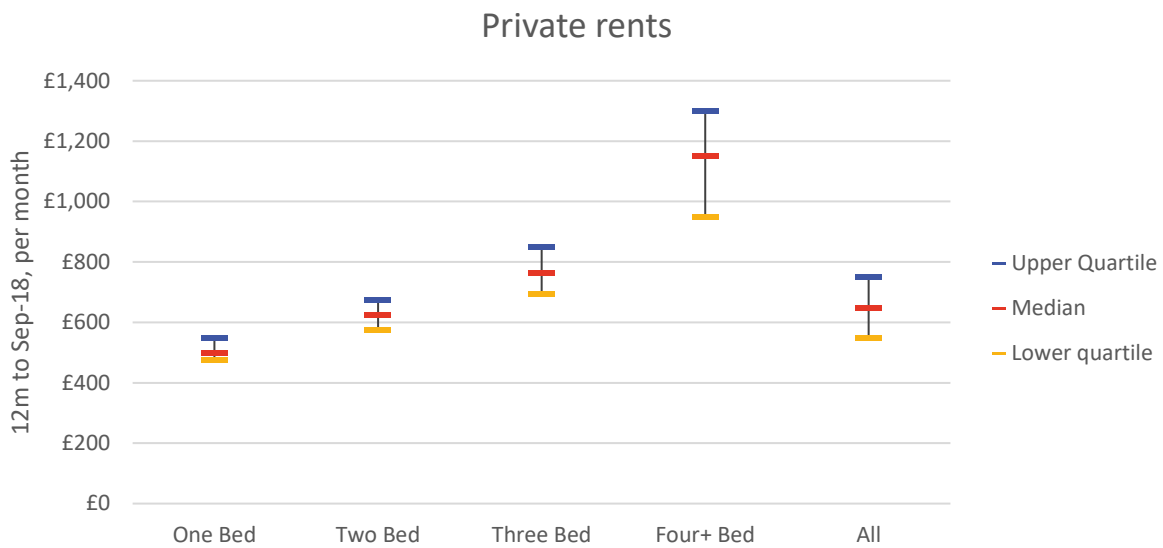
Sales distribution by house price

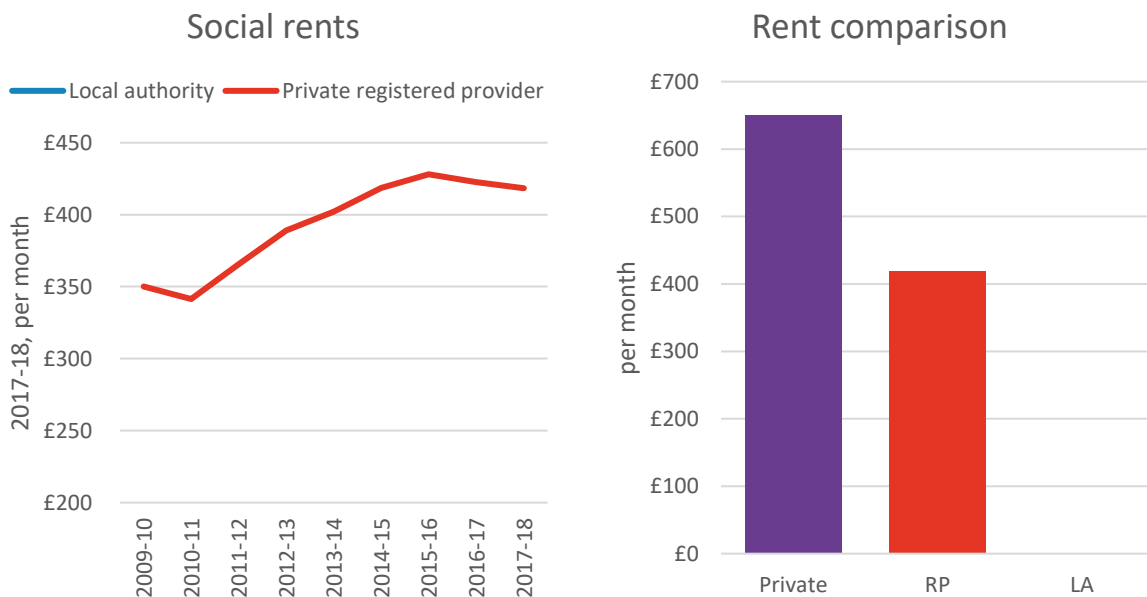
New homes made up 13.2% of the total 1,297 sales recorded by the Land Registry in 2018. 11.1% of total sales were flats, and 60.5% were under £300,000. By comparison, 66.0% of transactions nationally were under £300,000.

Private rents in Malvern Hills in the 12 months to September 2018 ranged from £475 per month for a lower quartile one bed to £1,300 for an upper quartile four (or more) bed property. The overall median private rent was £650, which is approximately the same as the England average of £690, suggesting high private rents may be a problem.

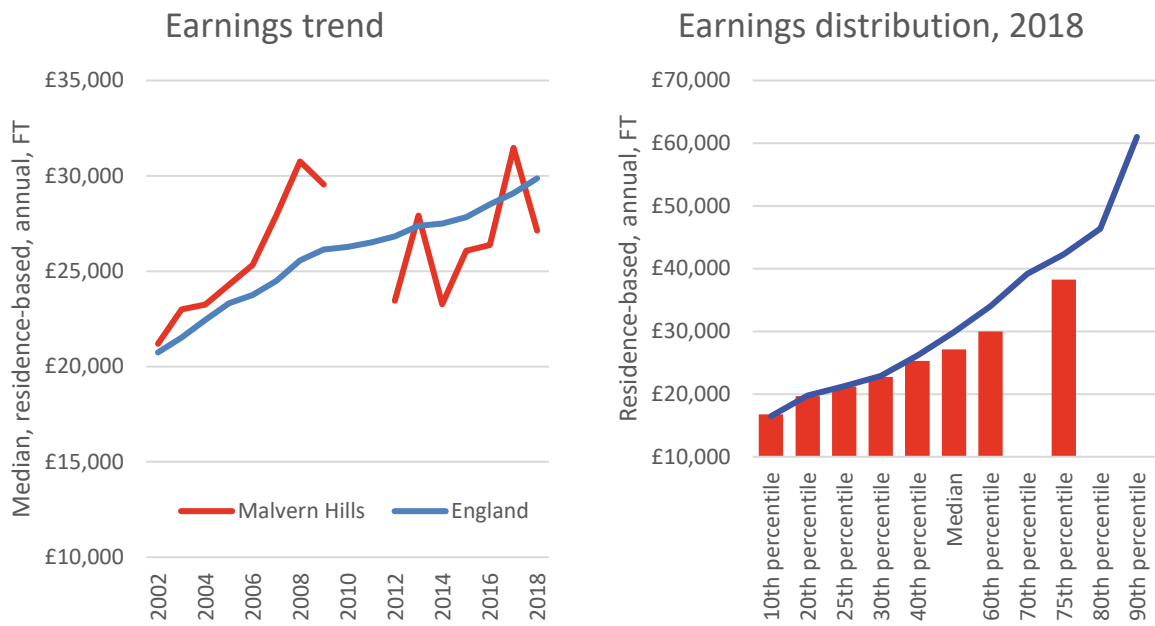

Social rents are approximately 64% of private rents in Malvern Hills. Average social rents have increased 7.6% over the past five years, compared with 9.3% at national level.

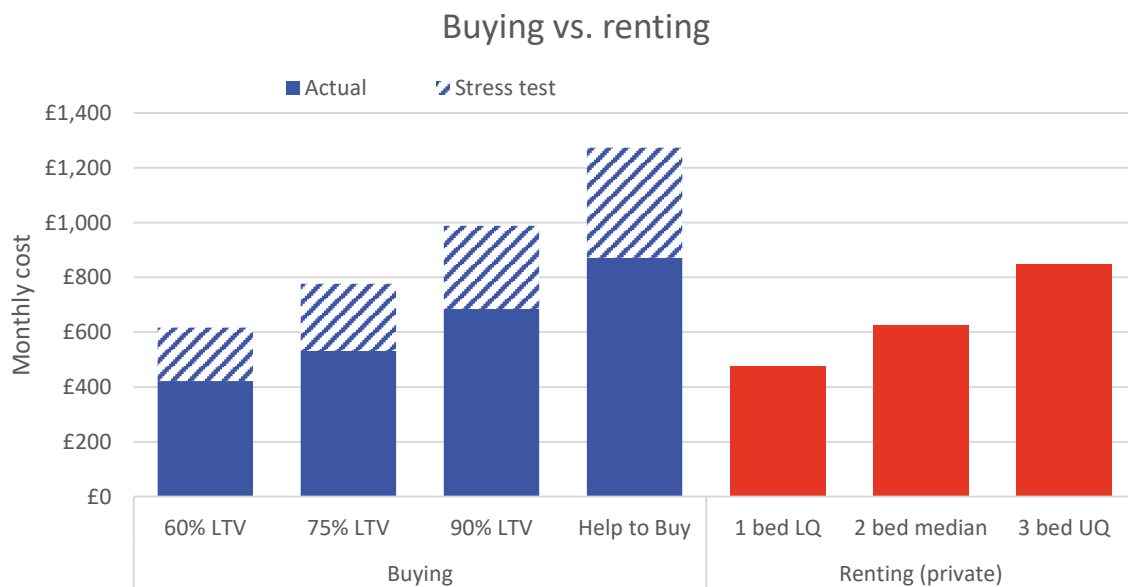

The median full-time earnings in Malvern Hills were £27,122 in 2018, compared to £29,869 in England. Half of local full-time workers earn between the lower quartile of £21,208 and the upper quartile of £38,264, compared to national figures of £21,273 and £42,285.

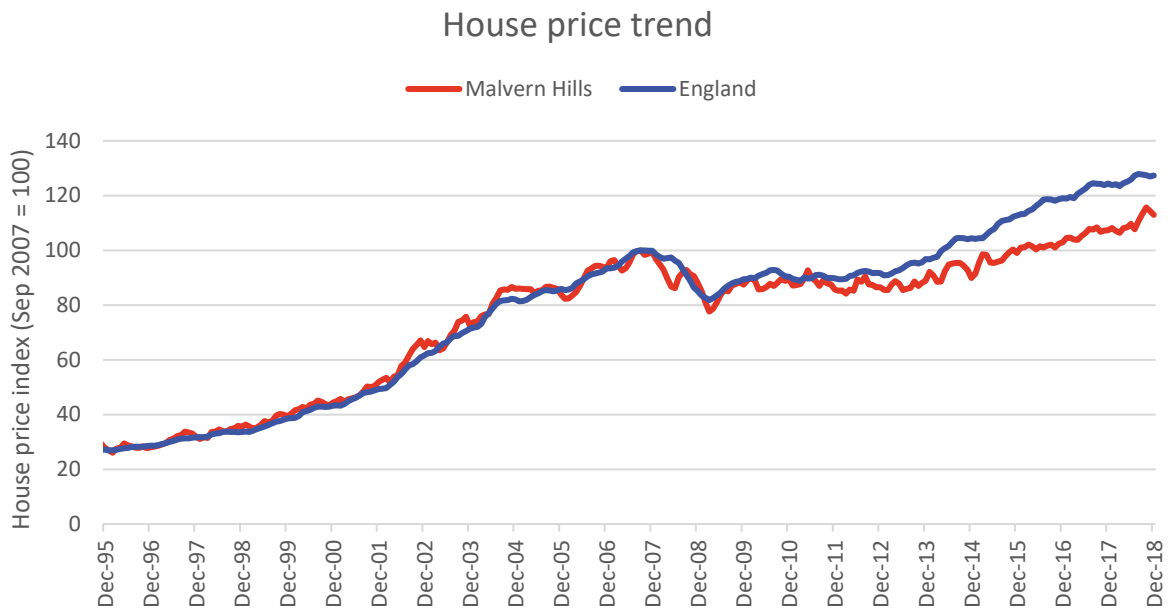

This chart shows a simple comparison of initial mortgage costs and rents for a range of scenarios to represent potential FTB decisions.

Note: Buying scenarios based on average terraced house value (flat in London), lower of £600k (HTB limit) or average new build for HTB, and includes +3% mortgage rate stress test.

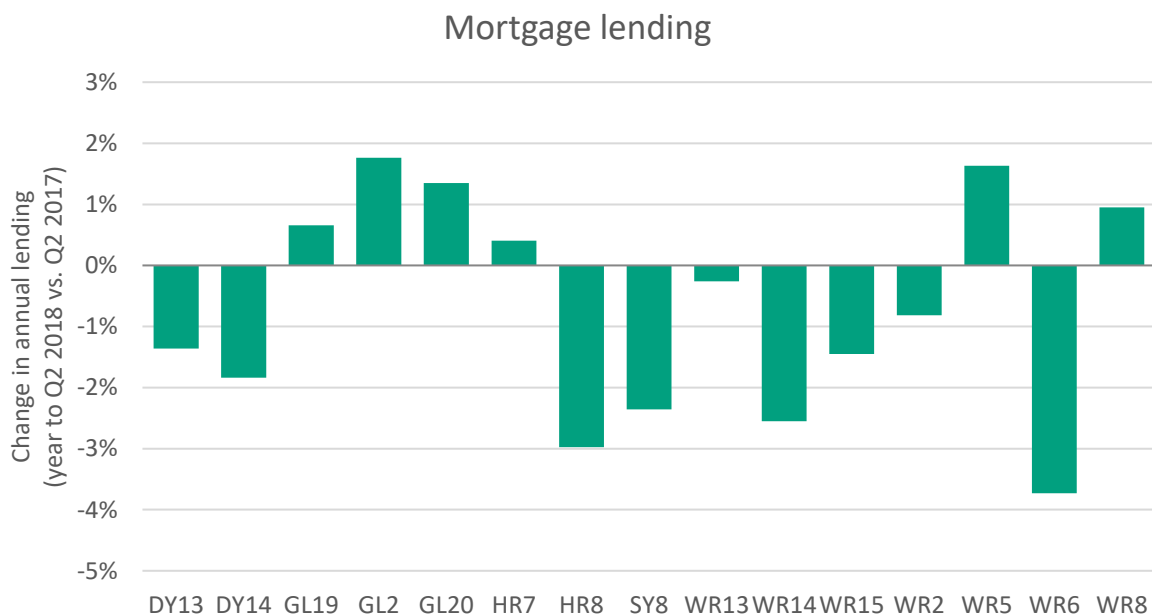

House prices in Malvern Hills in December 2018 are higher than their 2007/08 peak by 13.0%, compared with England at +27.3%. This suggests that rapid house price growth through the current cycle is unlikely to be a local problem. Values in 2018 increased by 5.3% annually.

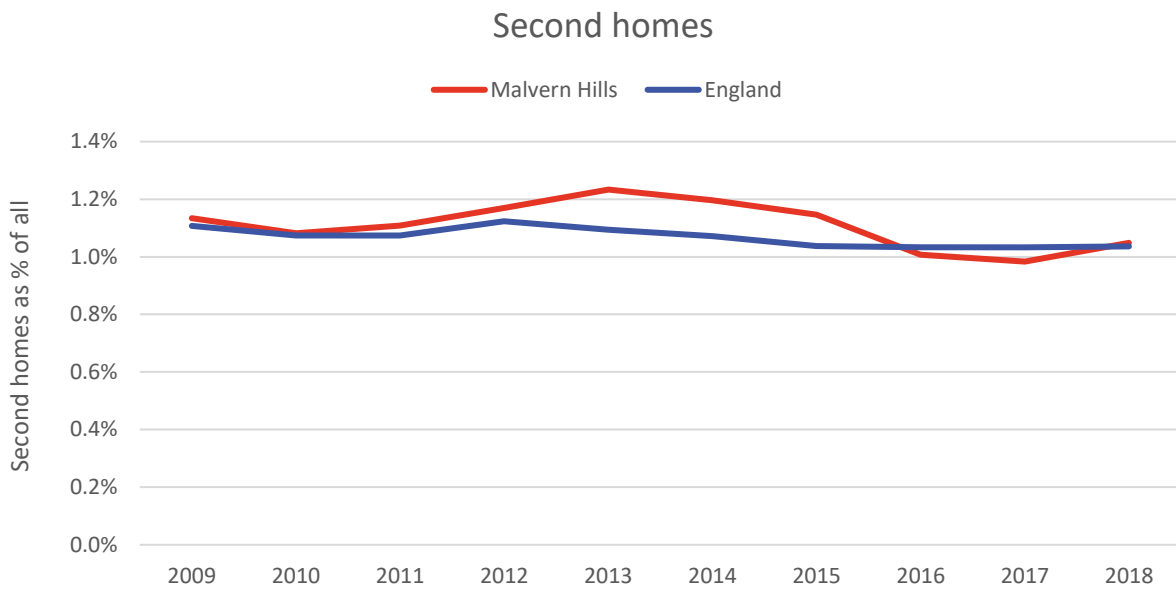
An indicative rental yield (based on ave 2 bed rent vs. ave flat sales value) for Malvern Hills is 4.8%, compared with 3.4% nationally.

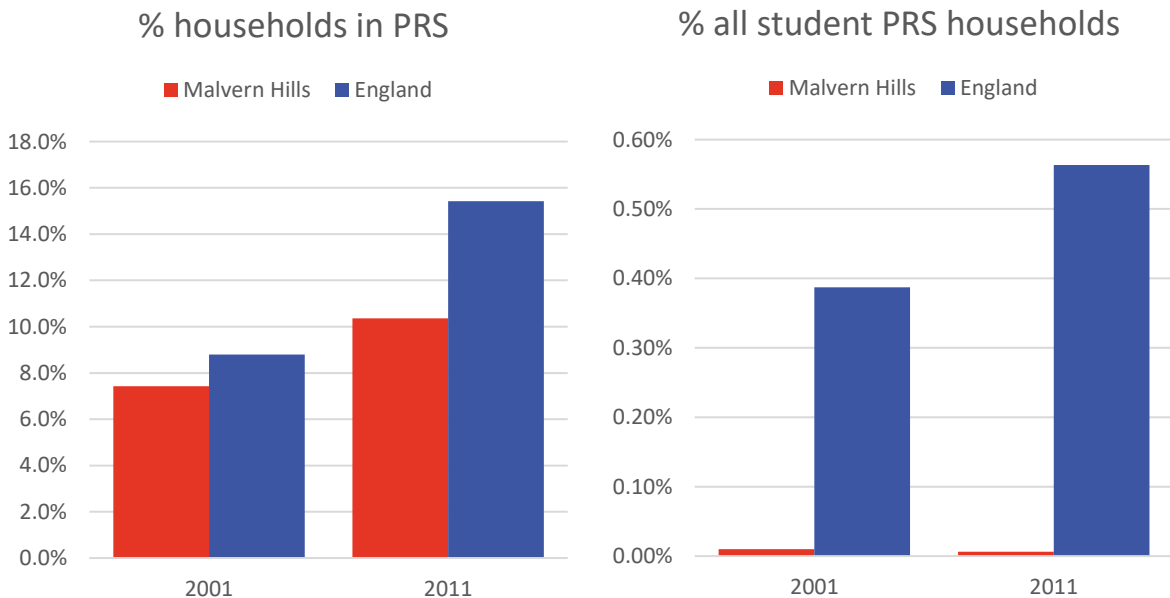
This chart shows the change in mortgage lending across the postcode districts in Malvern Hills. The total volume of lending in the 12 months to Q2 2018 was £4,037 million, compared with £4,041 million a year earlier, a change of -0.1%.

1.0% of residential properties in Malvern Hills were recorded as second homes in 2018 according to Council Tax Base data. This is approximately the same as the England average, suggesting high levels of second home ownership may be an issue, though other sources should be considered.

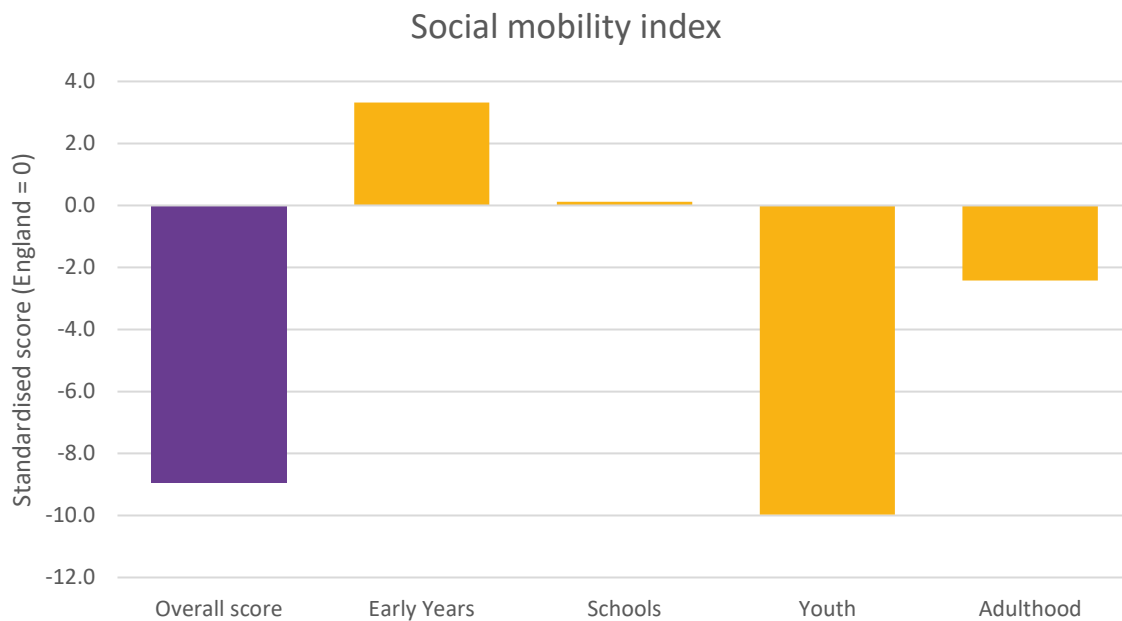

10.4% of households in Malvern Hills were rented privately according to the 2011 Census, compared to 7.4% in 2001. The England average changed from 8.8% to 15.4% over the same period.

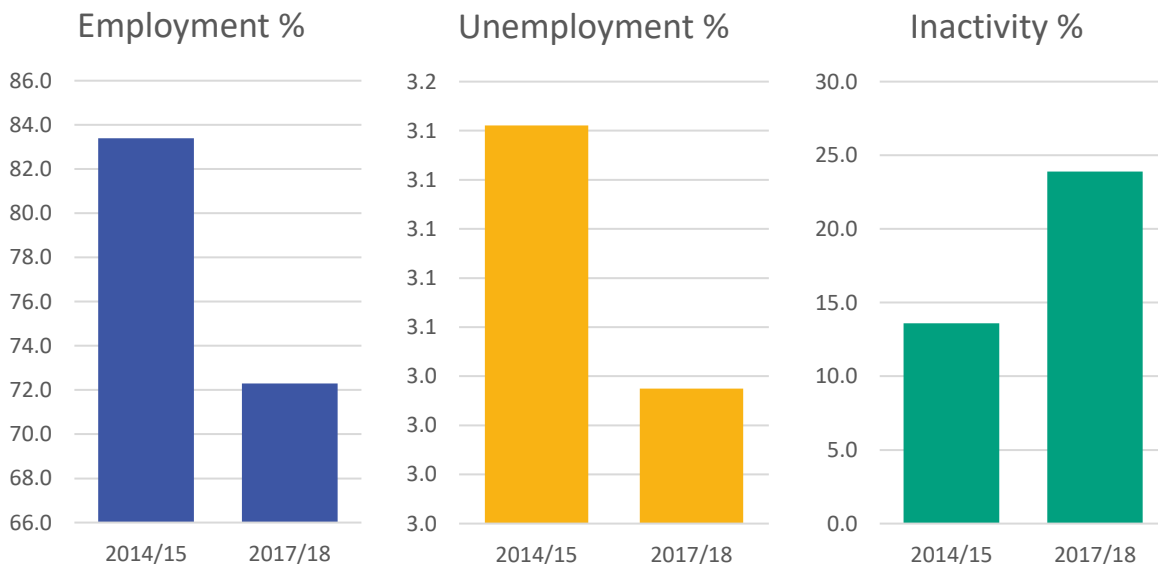
0.1% of the PRS households in Malvern Hills comprised only students in 2011, compared with 3.7% in England, suggesting students are not a significant part of the local PRS market.

Malvern Hills received an overall standardised score of -9.0 in the 2017 Social Mobility Index, compared to the England average of zero. Malvern Hills ranks as 200/324 for overall score across all English local authorities for which data is available. Local house price affordability could be a further barrier to social mobility in this area.

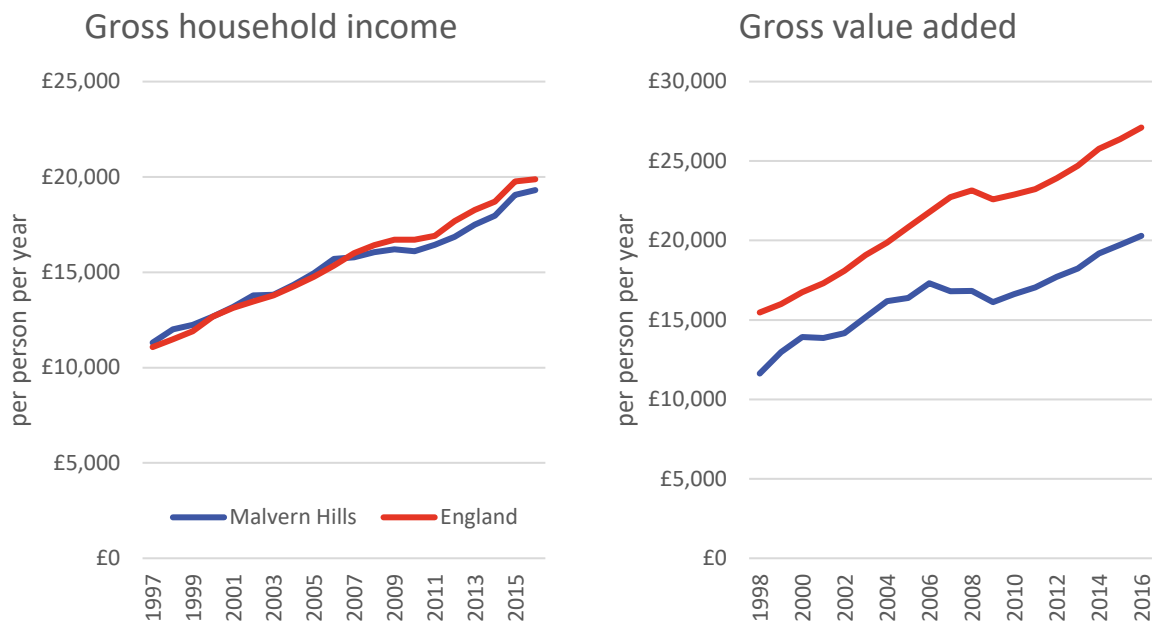

Employment in Malvern Hills changed from 83.4% in 2014/15 to 72.3% in 2017/18; unemployment changed from 3.1% to 3.0%; and economic inactivity changed from 13.6% to 23.9%.

By comparison, employment in England changed from 73.6% in 2014/15 to 75.3% in 2017/18; unemployment changed from 5.3% to 4.2%; and economic inactivity changed from 22.2% to 21.3%.

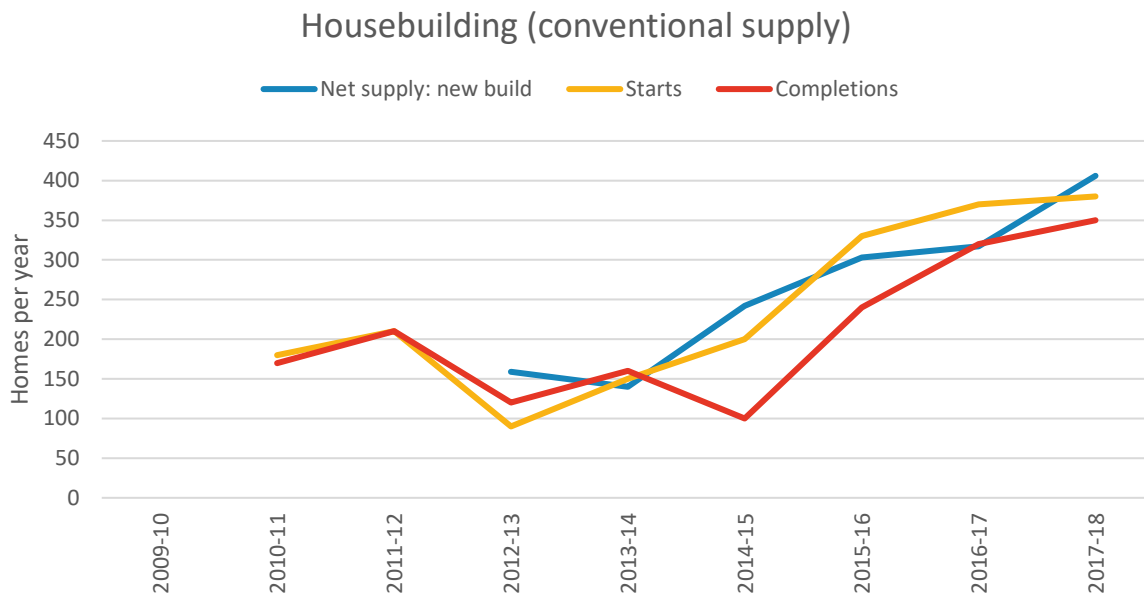

Gross domestic household income in Malvern Hills was £19,309 per person per year in 2016, compared with £15,701 in 2006. By comparison the figure for England changed from £15,349 to £19,878 over the same period. Based on this measure, Malvern Hills is an area of typical affluence.

Gross value added at district level was £20,294 per person per year in 2016, compared with £17,317 a decade earlier. By comparison the figure for England changed from £21,773 to £27,108 over the same period.

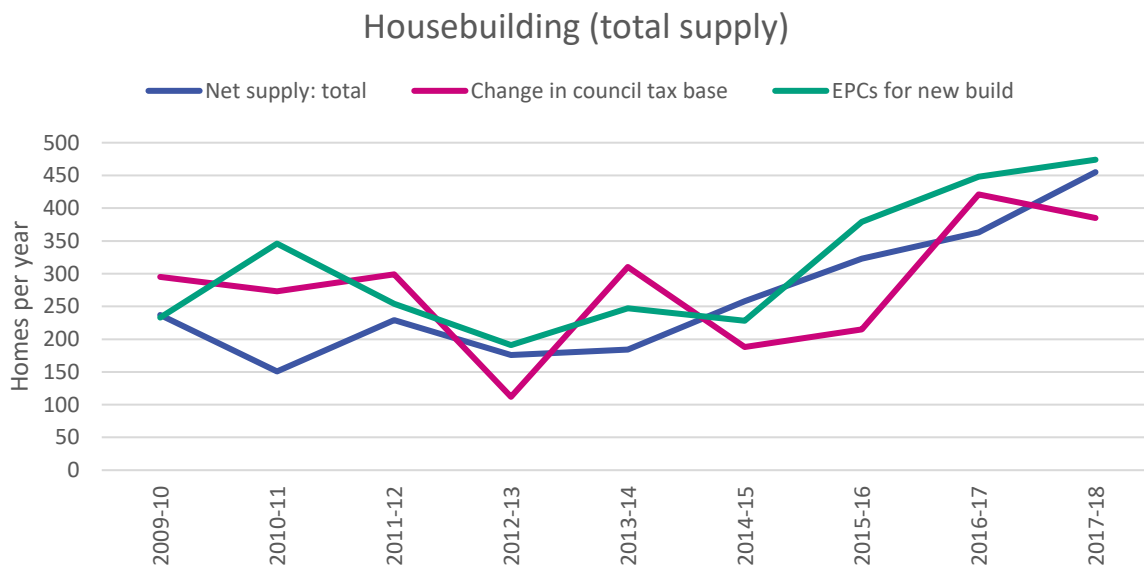

The measures of 'conventional' housebuilding for Malvern Hills are shown in this chart. The 'official' MHCLG supply figures for 2017-18 recorded 406 new build completions (excluding any conversions or change of use). Over the same period 350 completions were recorded in the 'unofficial' quarterly data, along with 380 starts.



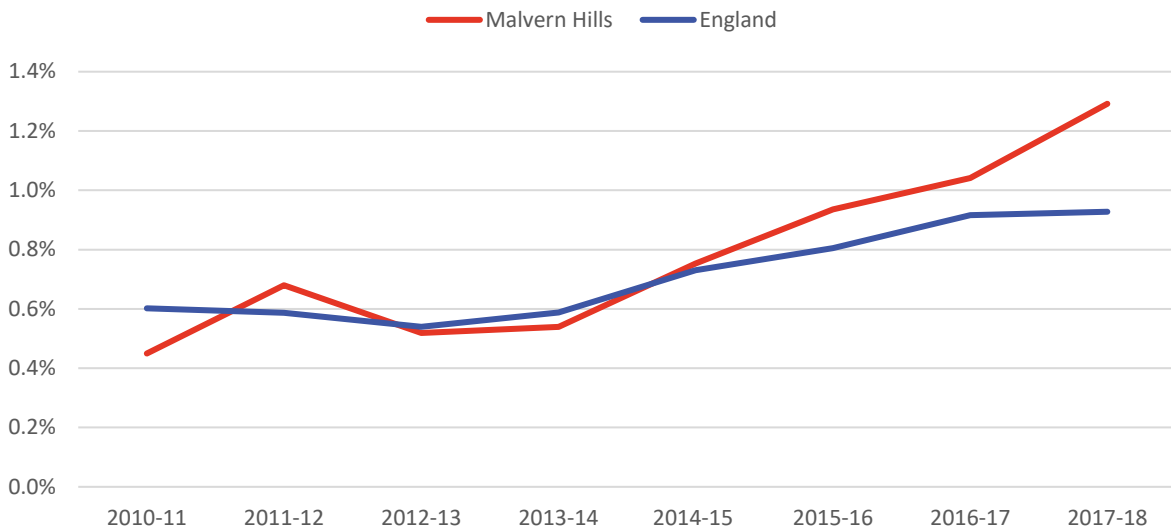

This chart shows total supply for Malvern Hills. The 'official' MHCLG supply figures for 2017-18 recorded 455 net new homes in total (including conversions and change of use, and after demolitions), and the Council Tax Base changed by +385 homes in the same period.

EPCs issued for new homes are used as a lead indicator of supply and can often be used to estimate net supply: 468 were recorded in the 2018 calendar year in Malvern Hills.

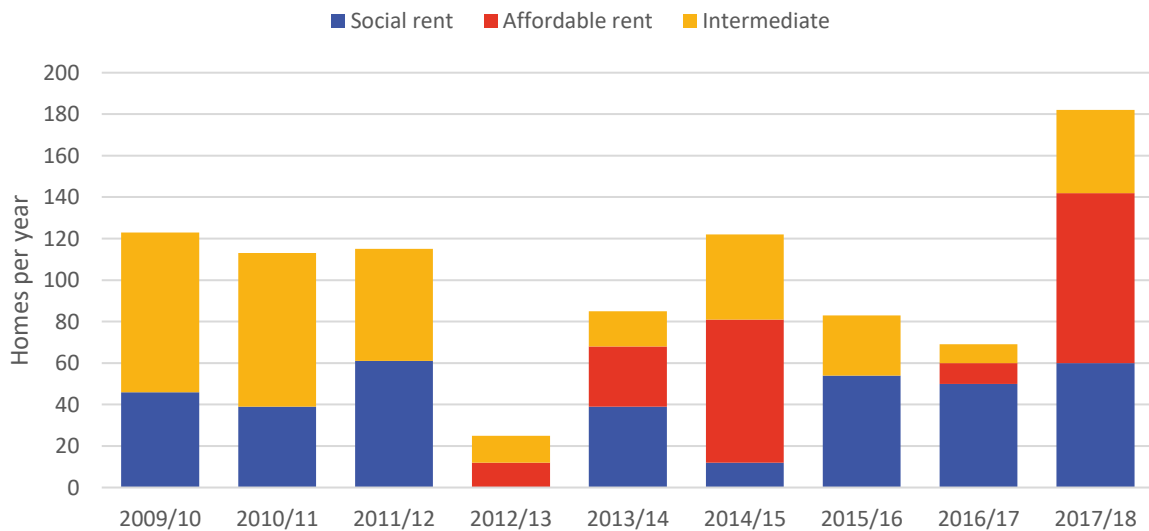
Net additions as % of stock

The net new supply in Malvern Hills increased the existing housing stock by 1.3% in 2017/18. This is much higher than the England average of 0.9%, suggesting the level of local supply is unlikely to be an issue. Note that the Government's national target of 300,000 homes per year is equivalent to 1.3%.

Affordable delivery

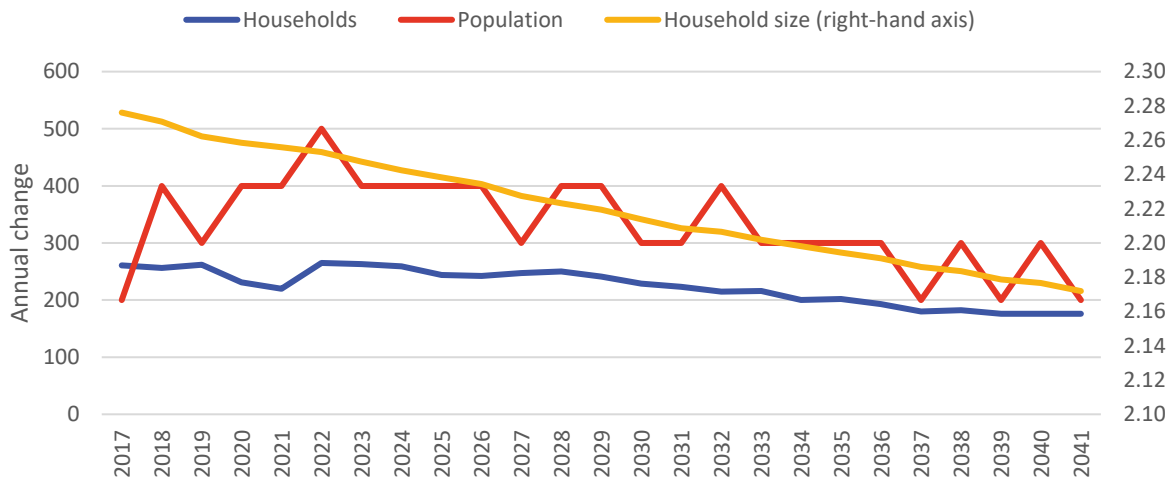

The previous analysis in this section covers delivery of all tenures / by all types of developer. This chart shows only delivery of affordable housing. In Malvern Hills 182 new affordable homes were completed in 2017/18: 60 for social rent, 82 for affordable rent and 40 intermediate affordable homes.

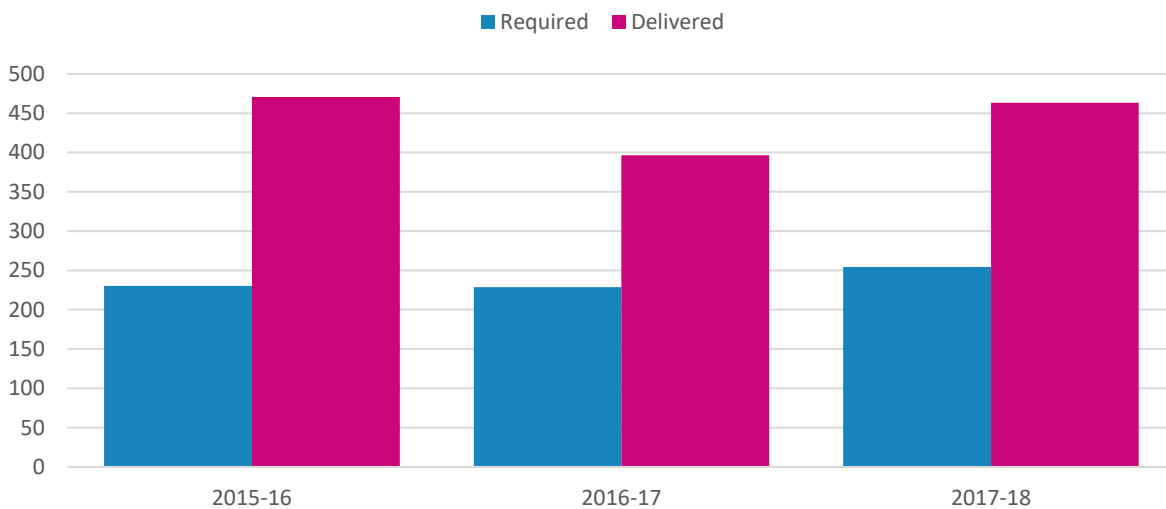
### Household and population projections

Population growth in Malvern Hills is set to average 336 people per year from 2020 to 2041, with projected average annual household growth of 220 households over the same period. The average household size in 2020 is projected to be 2.26, and 2.17 in 2041.

### Housing delivery test



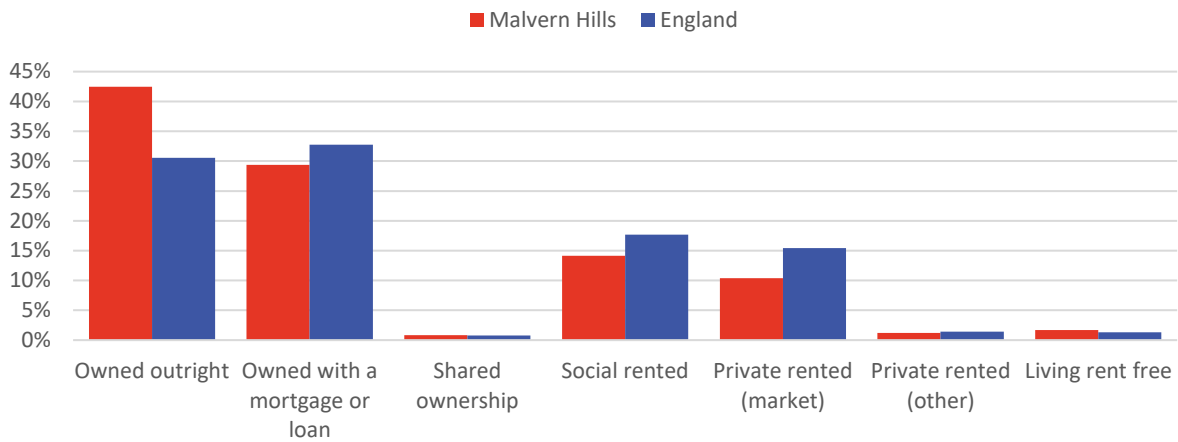

The most recent figures show that Malvern Hills delivered significantly more new homes than required by the MHCLG Housing Delivery Test. 1,330 net new homes were supplied over the past three full years, compared with the 713 required. The result of the test is that no action is required.

Note: Malvern Hills is assessed as part of a group of authorities for HDT purposes (Worcester; Malvern Hills; Wychavon). Figures above apportioned from group total based on # of dwellings in each district - may not match other supply analysis.

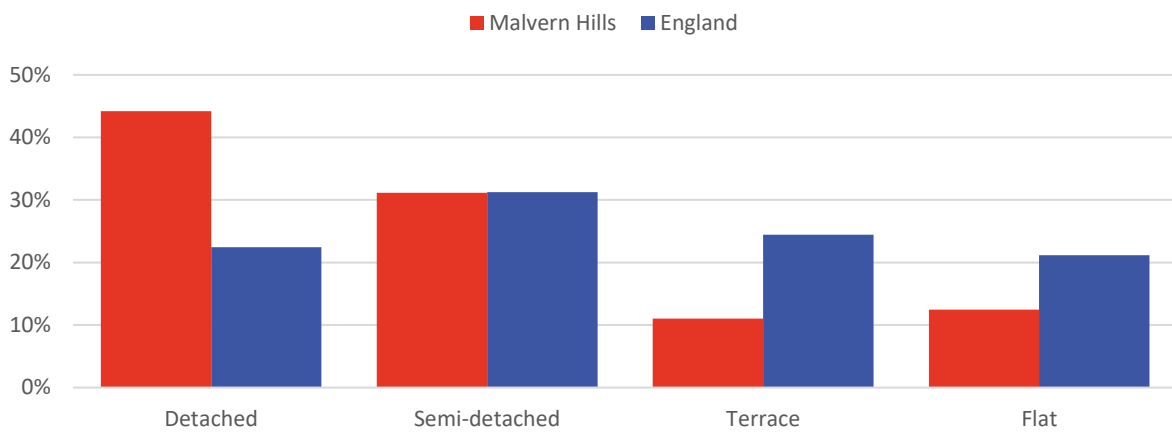

### Tenure



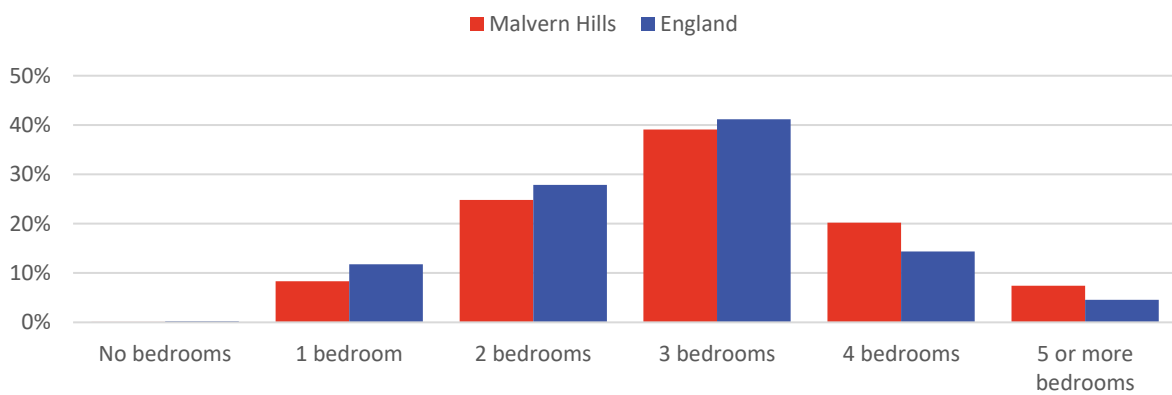

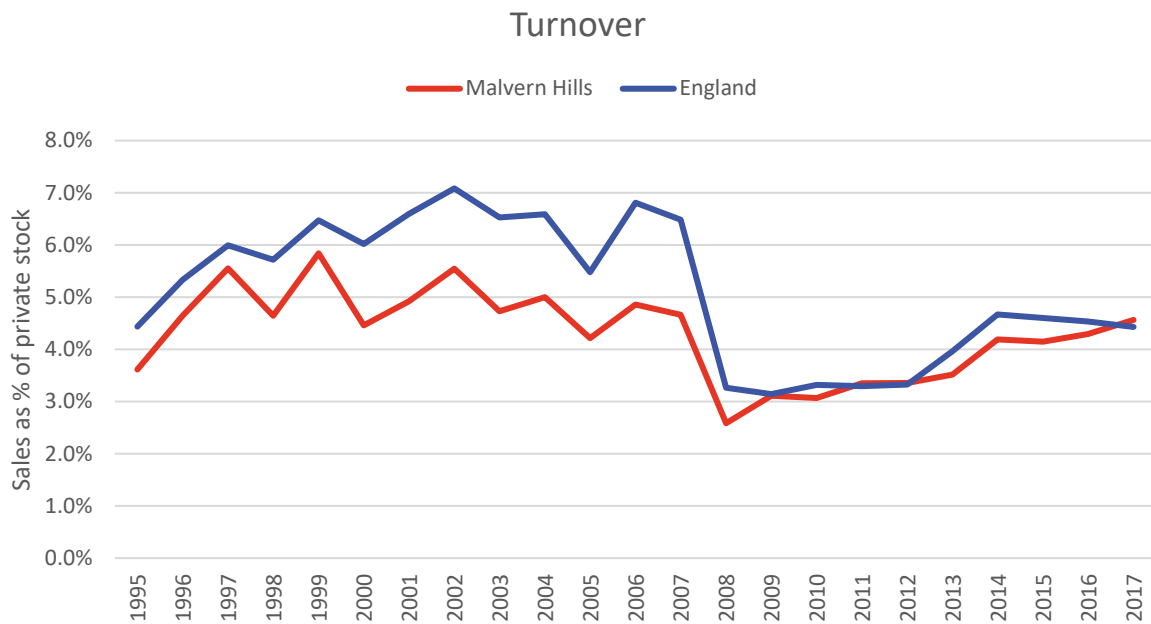
### Number of bedrooms

These three charts show property characteristics for Malvern Hills from the 2011 Census, compared to the national averages.

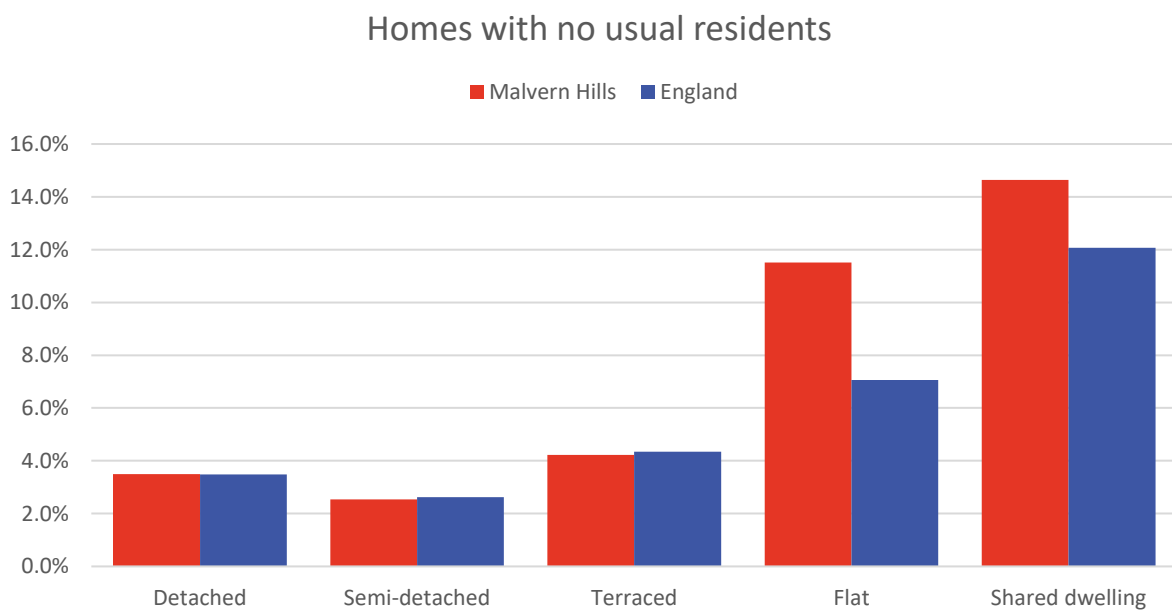

Turnover in Malvern Hills was 4.6% in 2017 (the latest year with full data). This is lower than the average before the global financial crisis (turnover from 2001-05 averaged 4.9%). For comparison turnover in England was 4.4% in 2017.

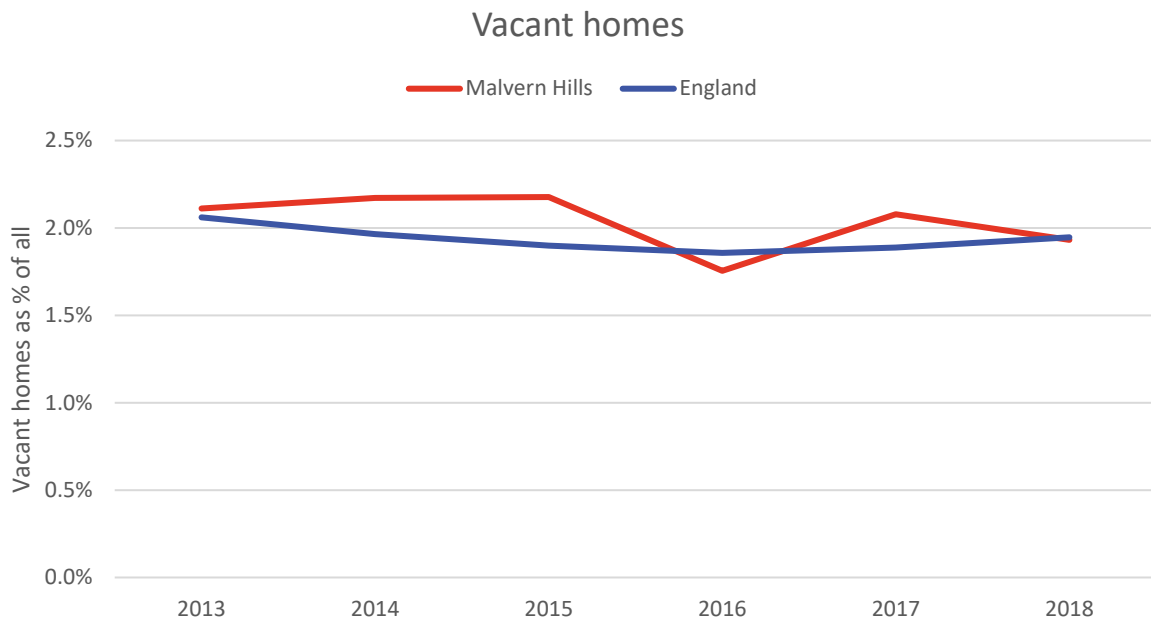
Note that the above analysis includes both standard Land Registry 'A' data and additional 'B' data (which covers repossessions, mortgaged buy-to-let and corporate transactions). In Malvern Hills in 2017 there were 51 'B' sales, 3.7% of the total.

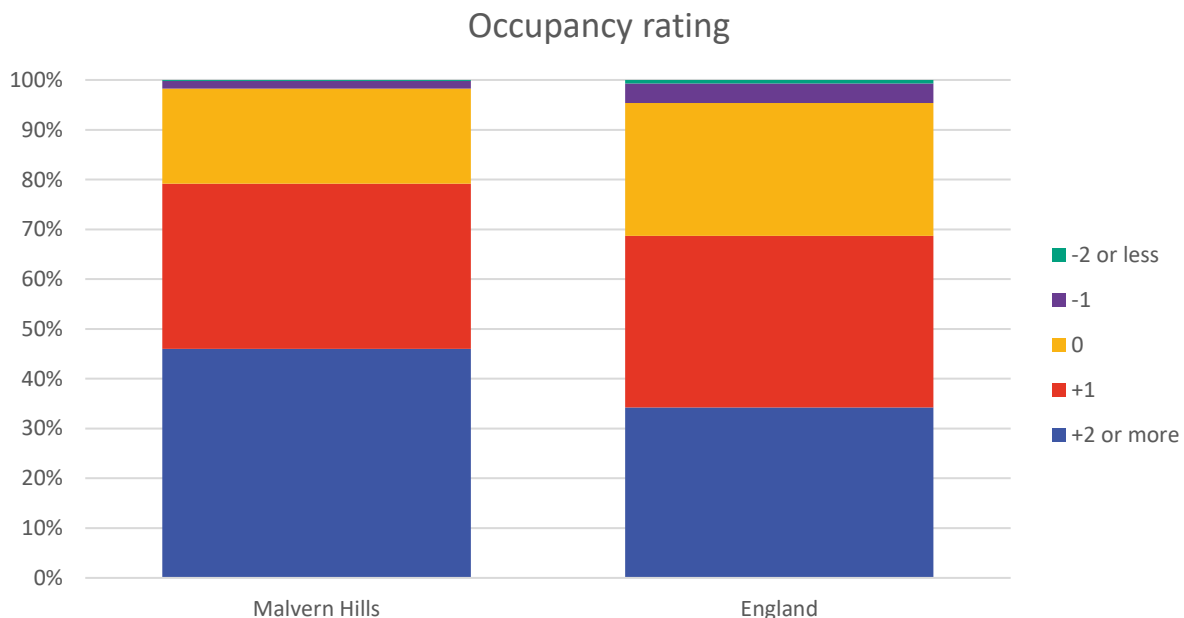
The proportion of homes with no usual residents in Malvern Hills was 4.5% according to the 2011 Census. This level is approximately the same as the England average of 4.3%.

1.9% of residential properties in Malvern Hills were recorded as vacant in 2018 according to Council Tax Base data. This is approximately the same as the England average, suggesting high levels of vacant homes may be a problem.

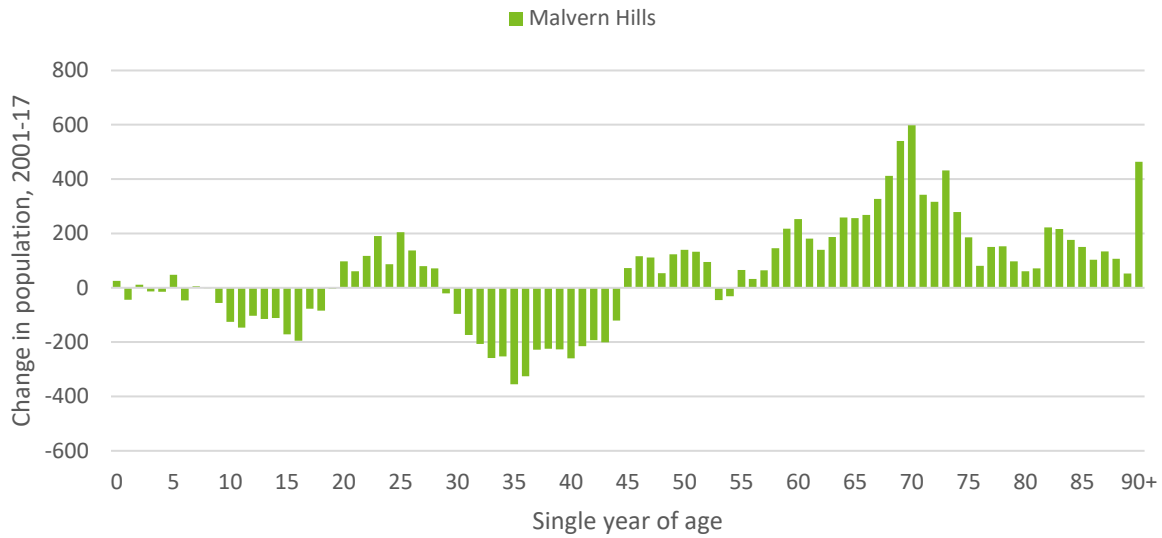

46.0% of homes in Malvern Hills had two or more spare bedroom, according to the 2011 Census. This is much higher than the England average, suggesting the distribution of housing is likely to be a significant problem.

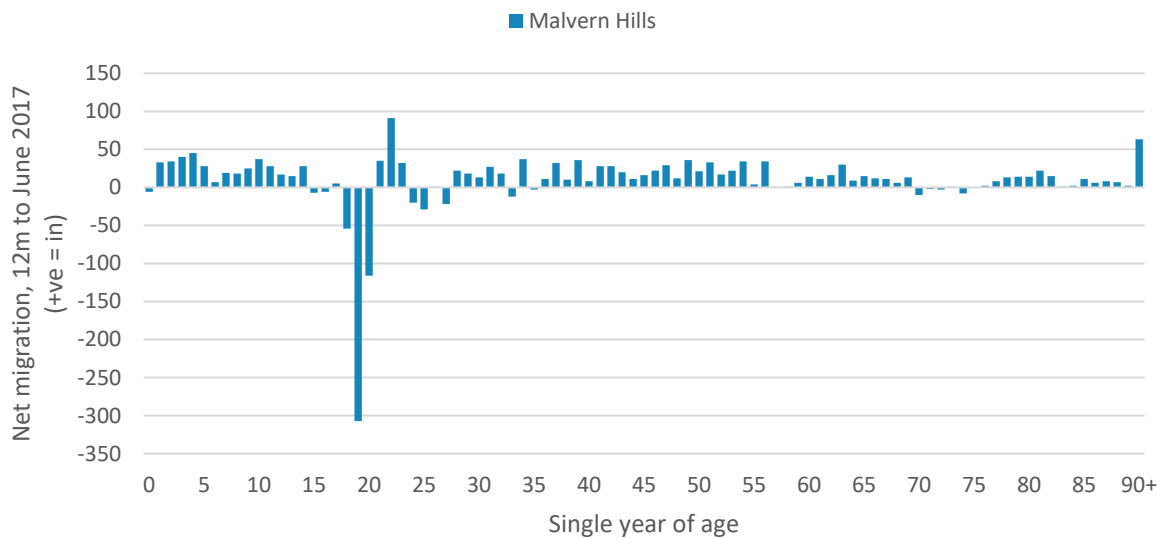
Population change by age, 2001-17

Overall, the population of Malvern Hills grew between 2001 and 2017, changing by +6.9%. Overall growth at national level over the same period was +12.5%. By age, the largest single contribution to growth was from 70 year olds.

Net migration by age

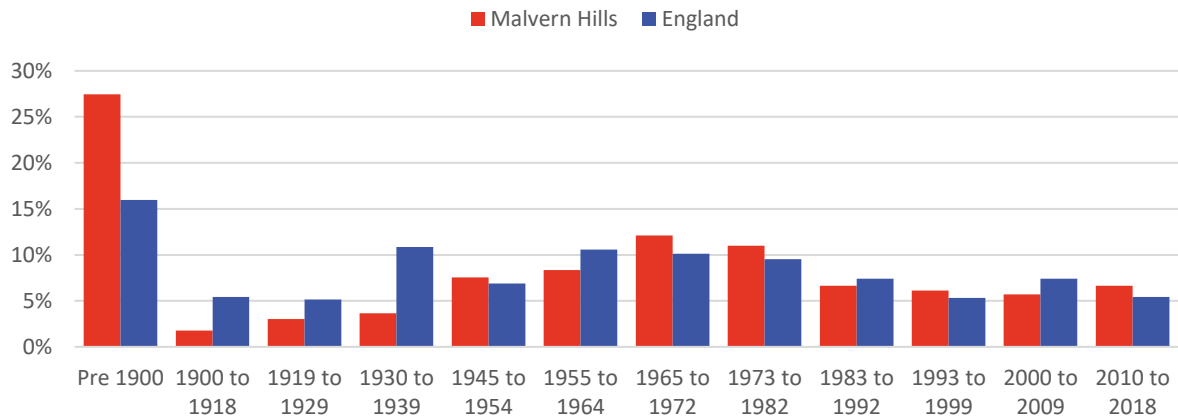

The overall population in Malvern Hills changed by +1.4% due to migration in the 12 months to June 2017: +1.1% from domestic sources and +0.2% from international. By age, the largest single contribution to growth was from 22 year olds.

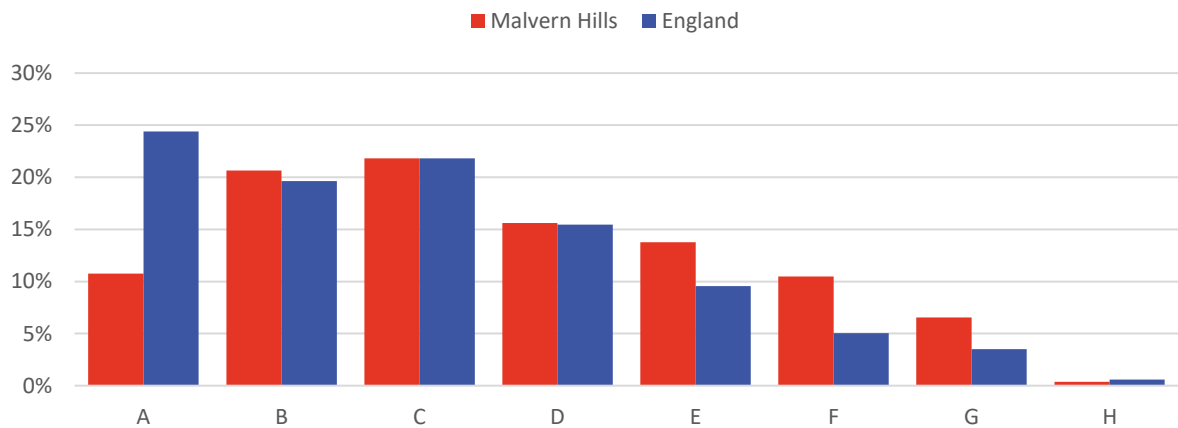

## Age of housing stock



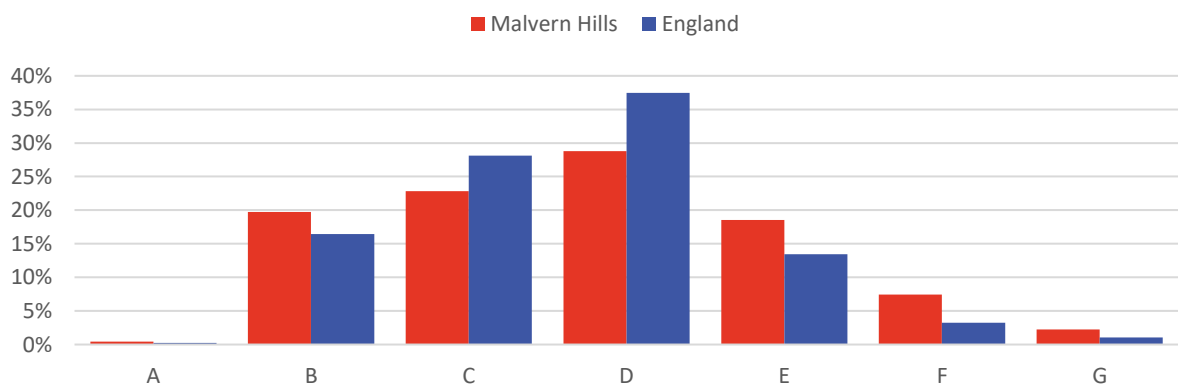

## EPC rating

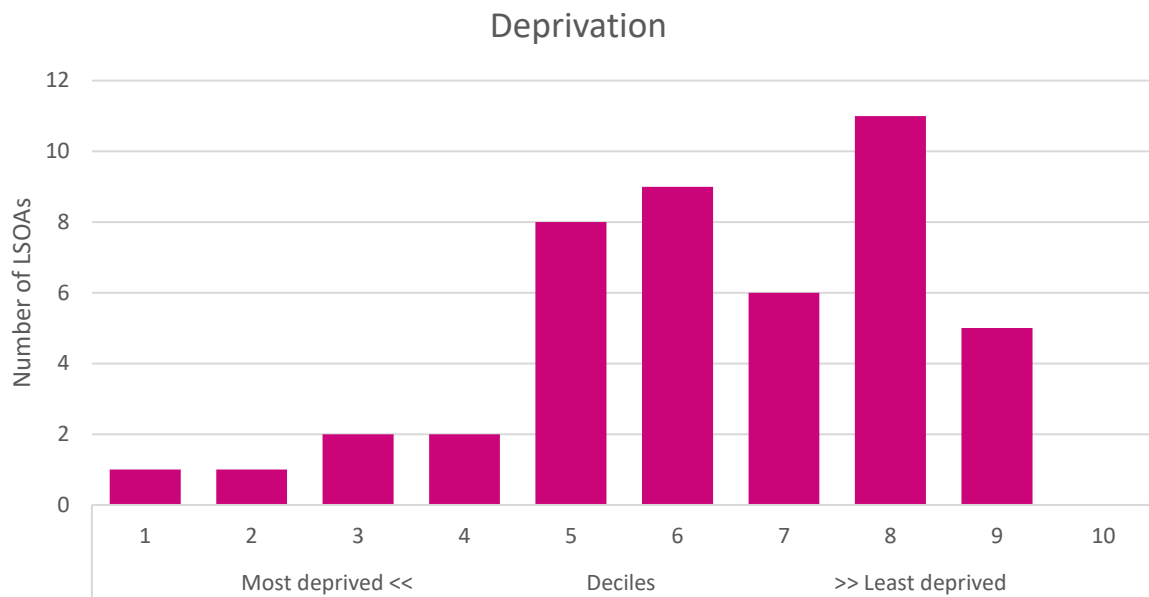

These three charts show property characteristics for Malvern Hills from the 2018 Council Tax Base, compared to the national averages.

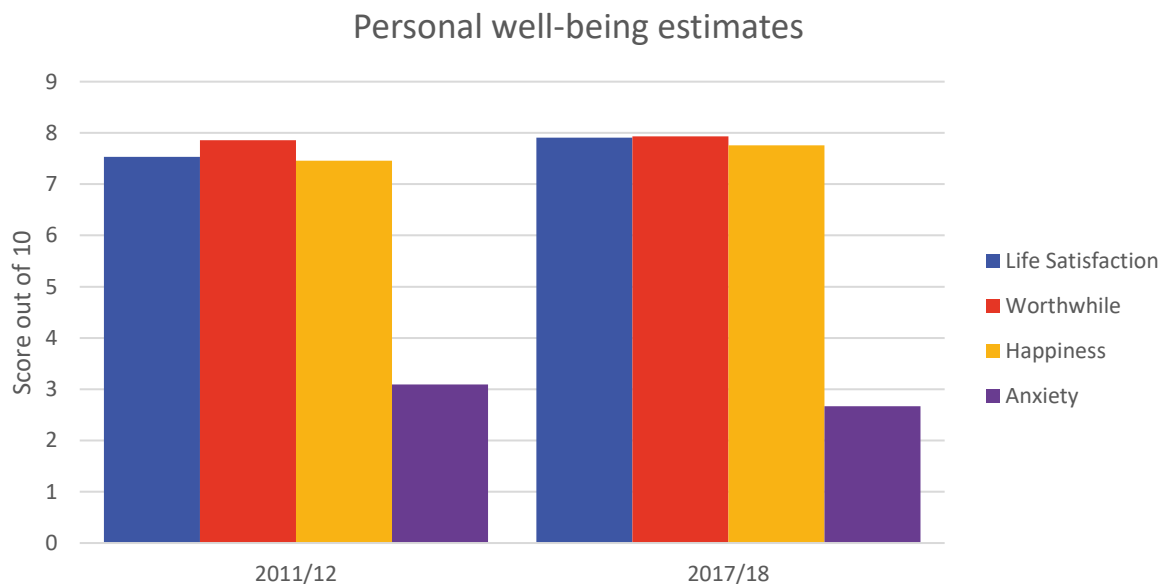

9% of the LSOAs in Malvern Hills are in the three most deprived deciles, based on the 2015 indices of multiple deprivation. This suggests it is an area of very low relative deprivation (the national average is 30%).



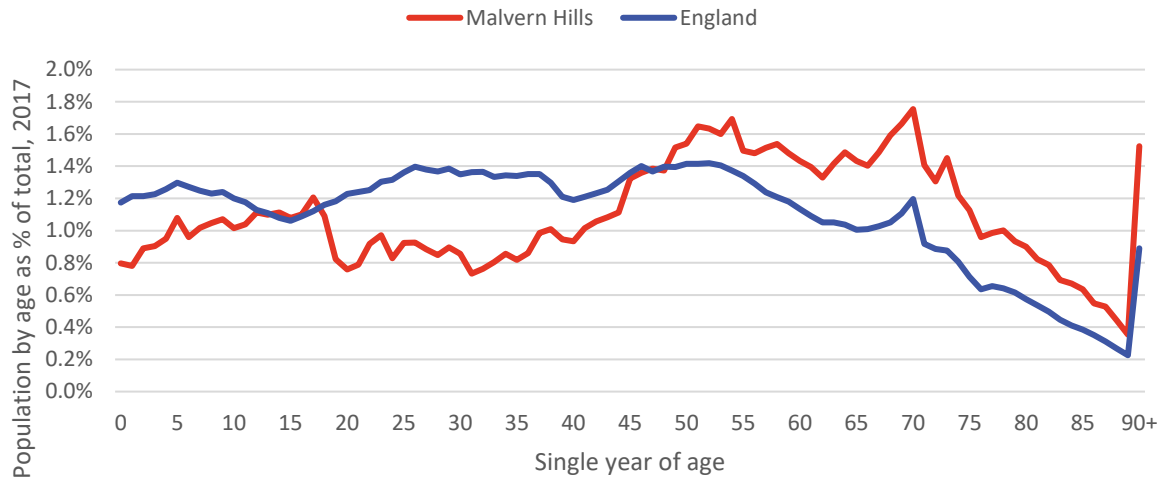

Residents of Malvern Hills scored their life satisfaction at 7.91 out of 10 on average in 2017/18, compared to the England average of 7.68. The corresponding figures for 2011/12 were 7.53 and 7.41 respectively.

Over all four categories combined, local people have higher than average levels of well-being in 2017/18, compared to the national figures.

## Population structure

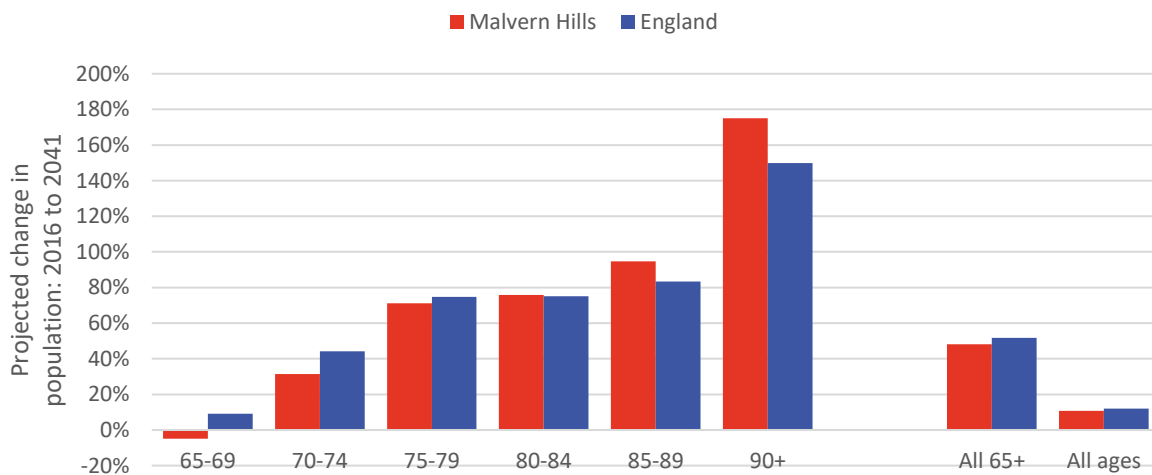

The population structure of Malvern Hills comprised 6.2% aged 18 to 24, 47.9% aged 25 to 64, and 27.6% aged 65 and over in 2017. The corresponding figures for England were 8.7%, 51.9% and 18.0%.

This suggests that the local population may include a lower than average level of students, along with a significantly higher than average level of older people.

## Population growth: older people

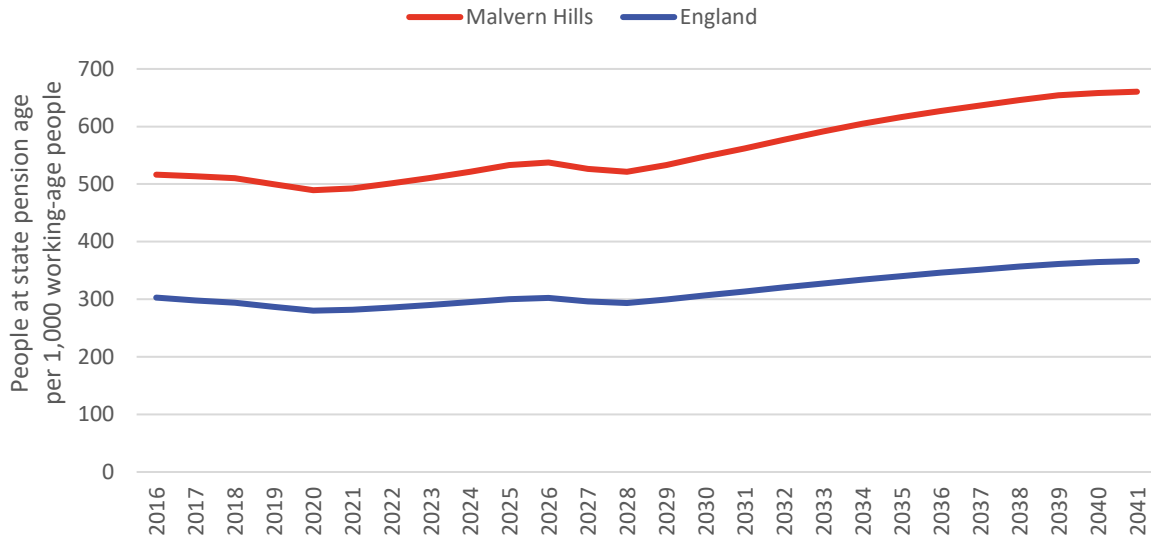

The 65 and over population of Malvern Hills is expected to grow by 48.1% from 2017 to 2041, according to the latest ONS population projections. This is compared to an overall population change of +10.8%. The corresponding national figures are growth of 51.7% and 12.1% respectively.

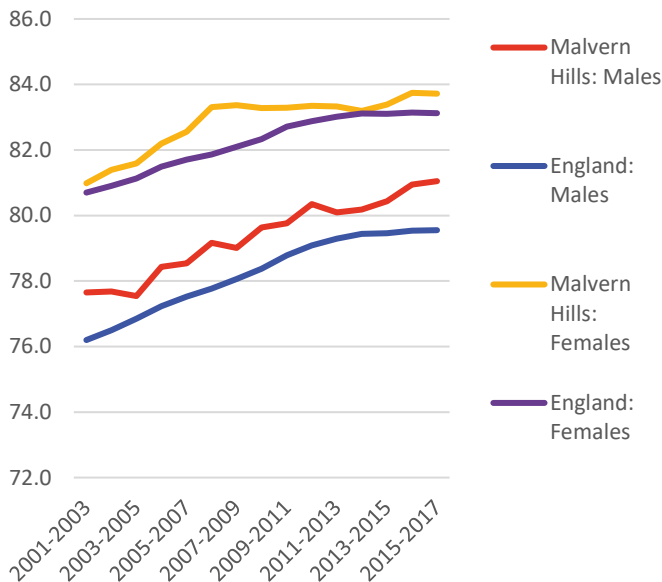
## Old age dependency ratio



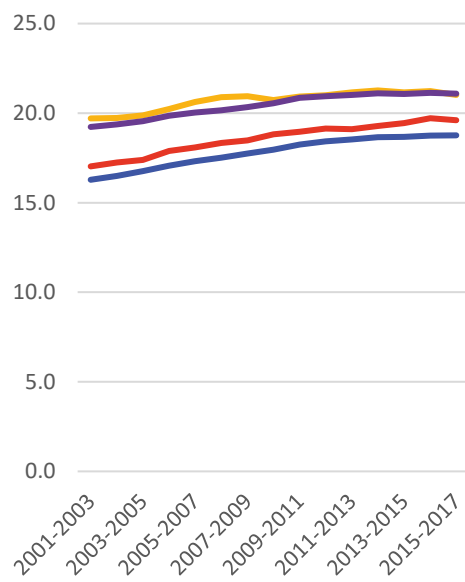

In Malvern Hills in 2019 there are expected to be 499.7 people of state pension age for every 1,000 working-age people, compared to an average of 286.8 at national level. By 2041 these rates are projected to reach 660.4 and 366.4 respectively.

## Life expectancy at birth



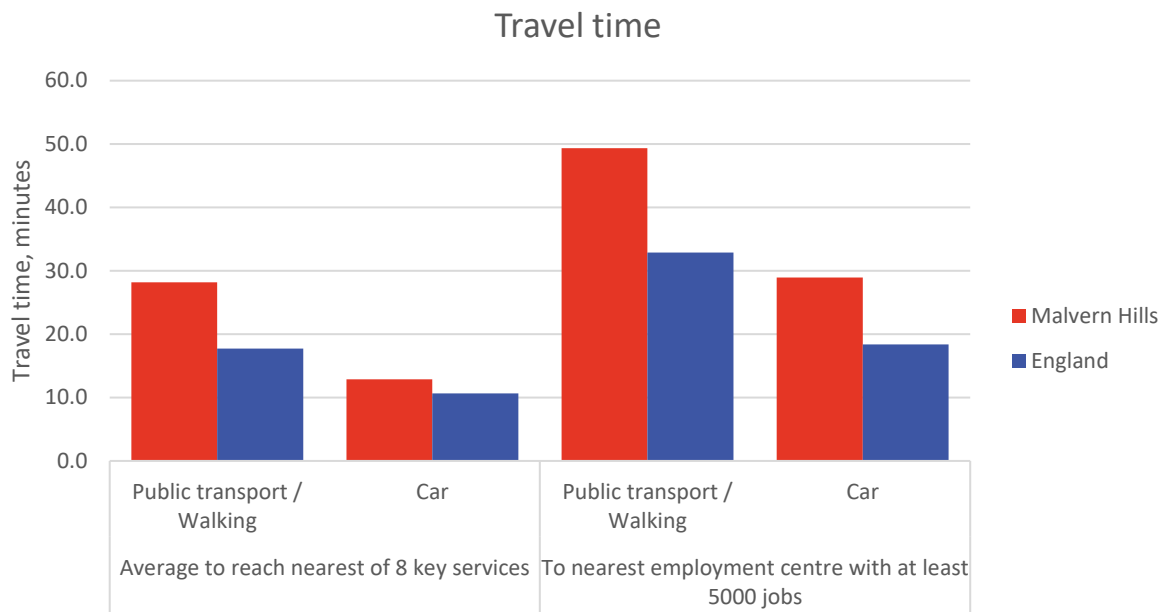
## Life expectancy at age 65

The average life expectancy for people born in 2015-17 in Malvern Hills is 81.0 years for men and 83.7 years for women. The equivalent national figures are 79.6 and 83.1 respectively.

Malvern Hills has well below average public transport connectivity compared to the national figures, with an average travel time to reach the nearest 8 key services of 28.2 minutes (England average = 17.7).
