

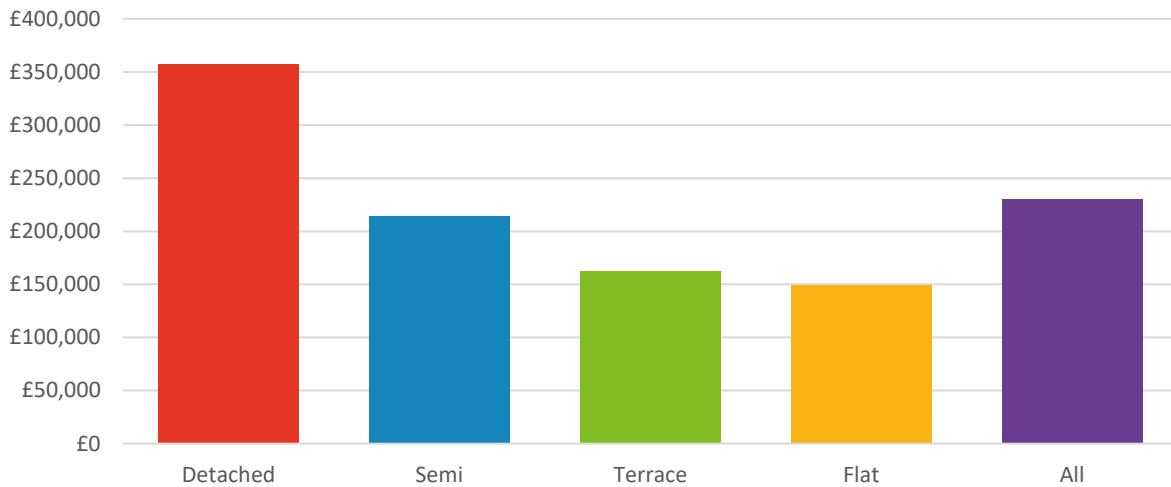

1. Affordability

Average house prices

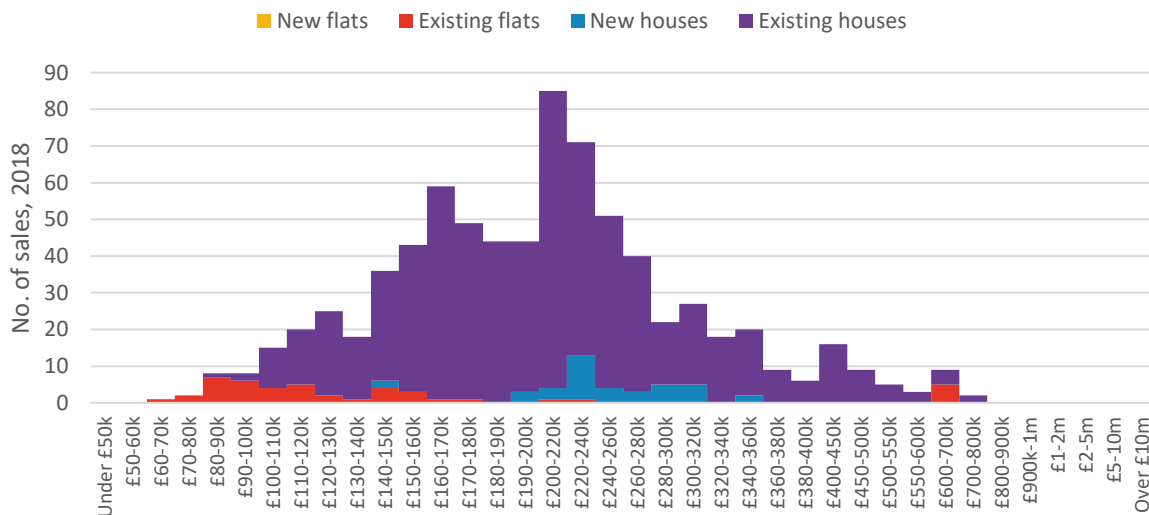

The average house price in Oadby and Wigston in 2018 was £230,000. The median ratio of house prices to local earnings is 7.5. This is approximately the same as the England average of 8.0, suggesting high house prices may be an issue.

According to 2016 ONS data, the average price per square metre was £2,036 with the average price per bedroom £45,441 - the corresponding national average figures were £2,463 and £55,087.

Sales distribution by house price

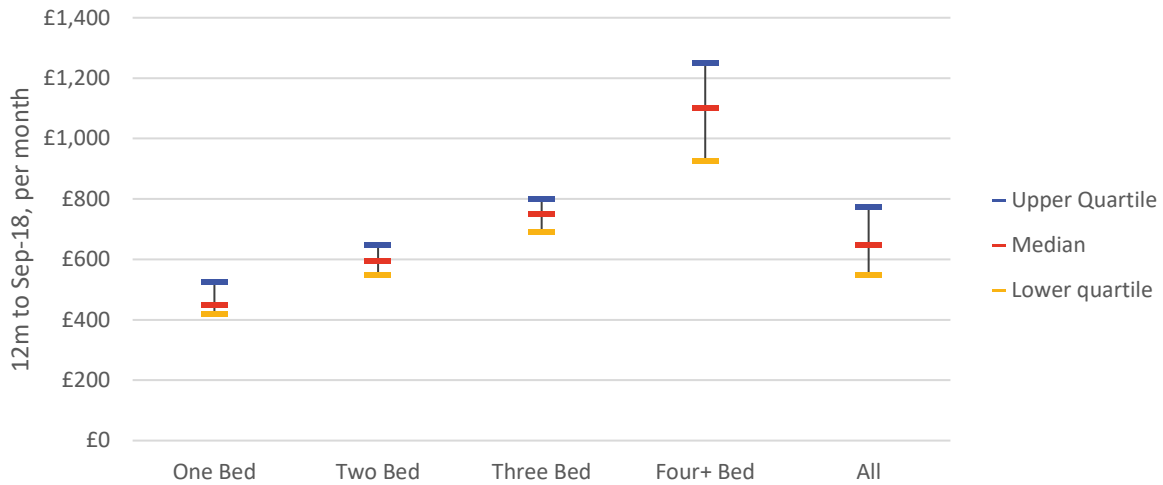

New homes made up 5.1% of the total 765 sales recorded by the Land Registry in 2018. 5.8% of total sales were flats, and 83.8% were under £300,000. By comparison, 66.0% of transactions nationally were under £300,000.

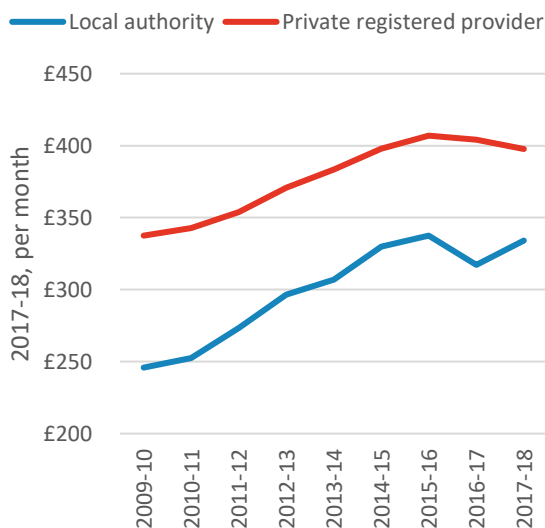

Private rents in Oadby and Wigston in the 12 months to September 2018 ranged from £420 per month for a lower quartile one bed to £1,250 for an upper quartile four (or more) bed property. The overall median private rent was £650, which is approximately the same as the England average of £690, suggesting high private rents may be a problem.

Rent comparison

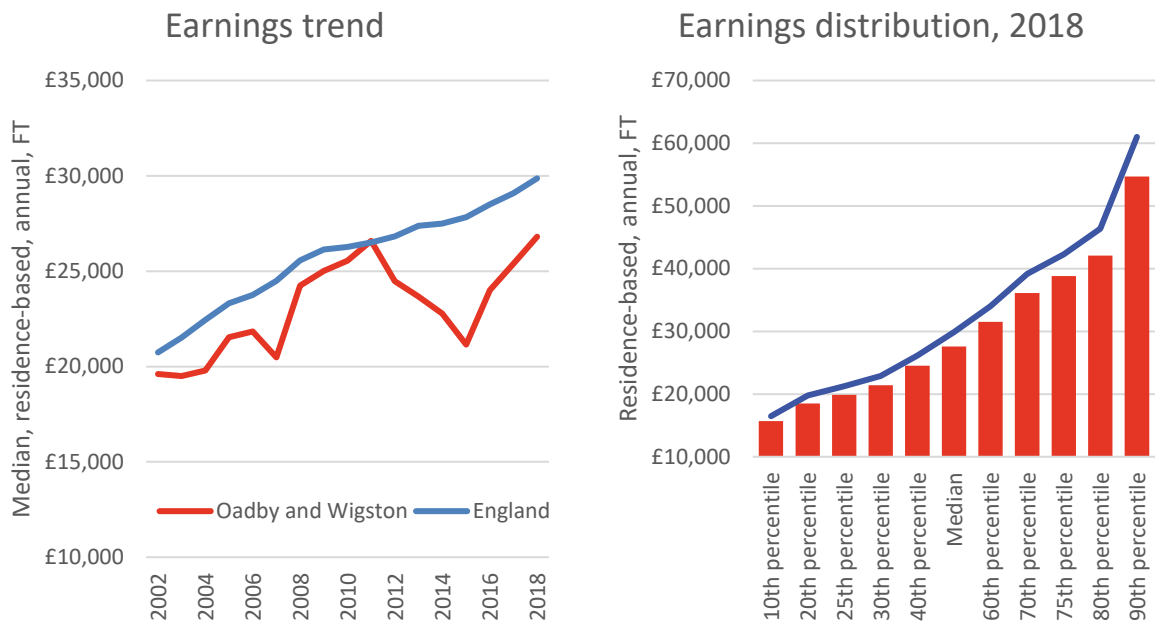

Social rents are approximately 56% of private rents in Oadby and Wigston. Average social rents have increased 9.9% over the past five years, compared with 9.3% at national level.

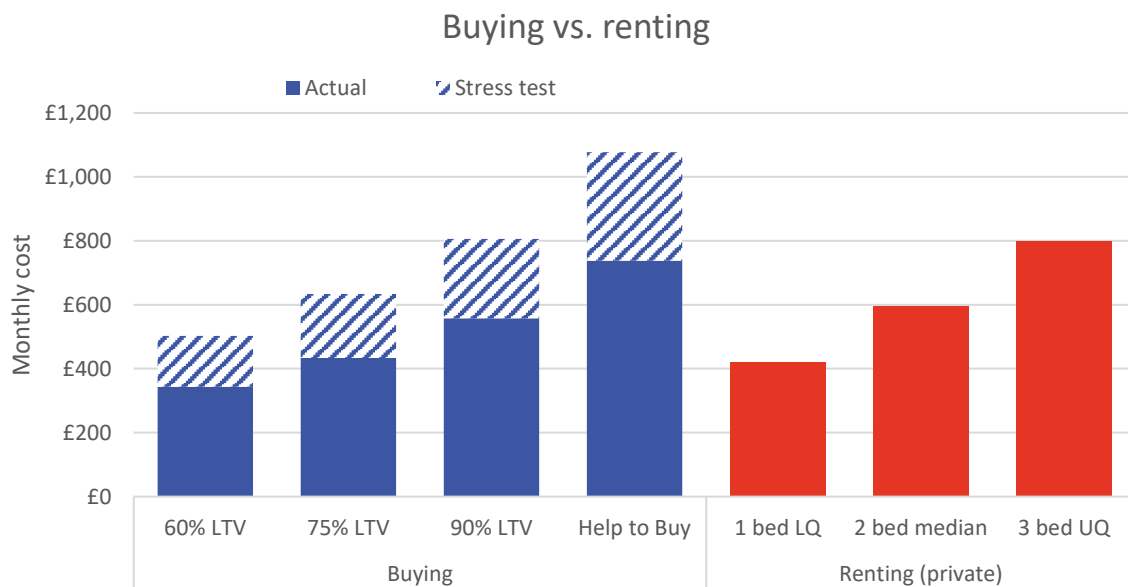

The median full-time earnings in Oadby and Wigston were £27,606 in 2018, compared to £29,869 in England. Half of local full-time workers earn between the lower quartile of £19,895 and the upper quartile of £38,816, compared to national figures of £21,273 and £42,285.

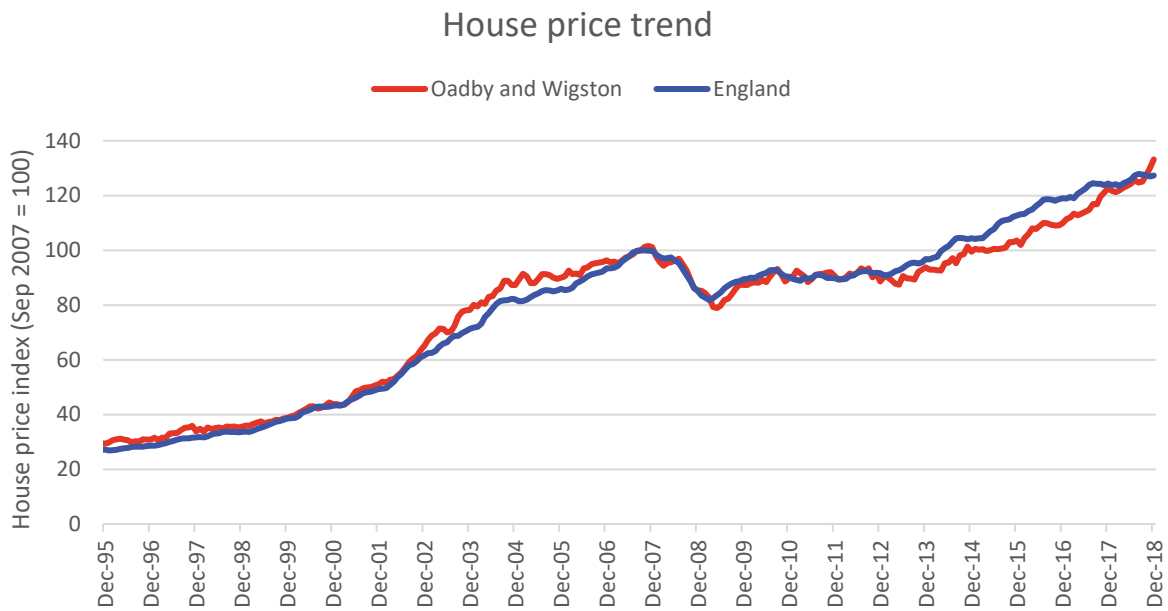

This chart shows a simple comparison of initial mortgage costs and rents for a range of scenarios to represent potential FTB decisions.

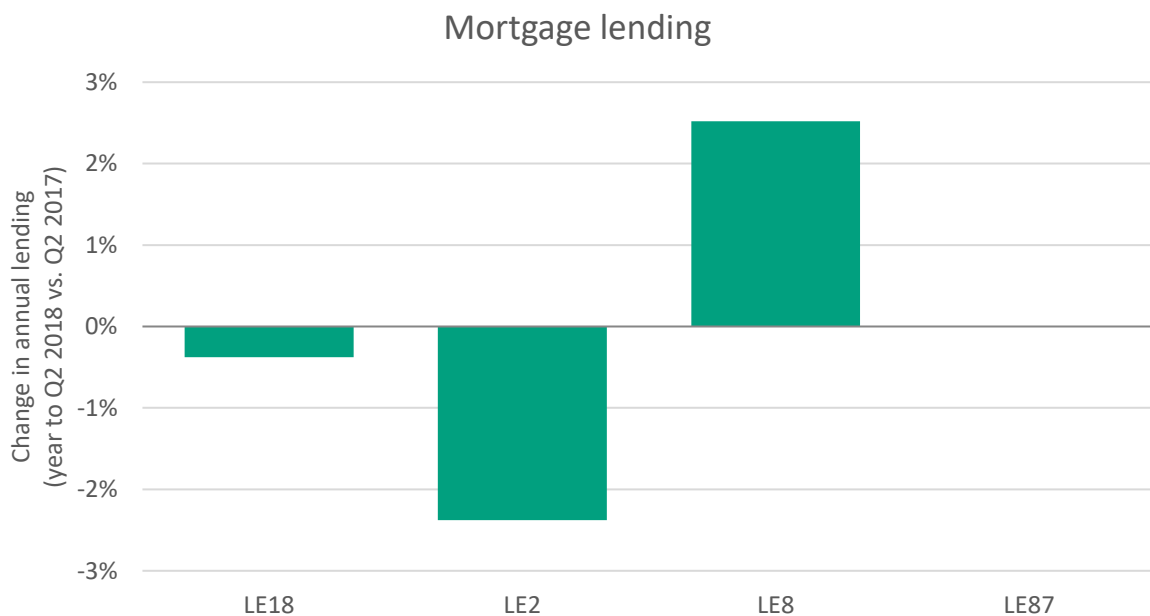

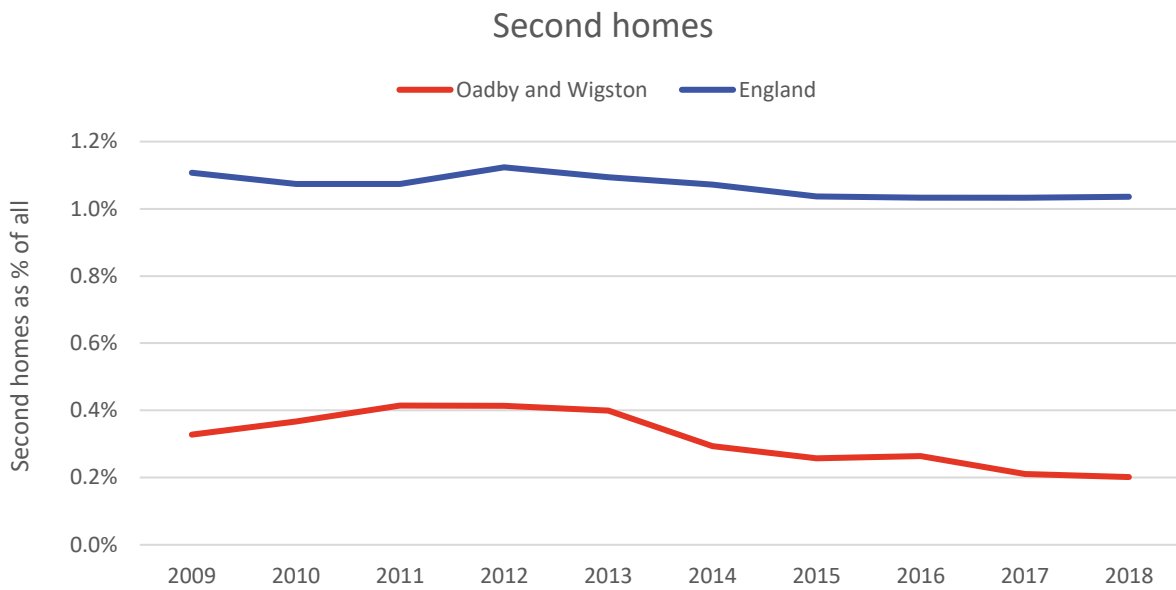
House prices in Oadby and Wigston in December 2018 are higher than their 2007/08 peak by 31.1%, compared with England at +27.3%. This suggests that rapid house price growth through the current cycle is likely to be a local problem. Values in 2018 increased by 8.6% annually. An indicative rental yield (based on ave 2 bed rent vs. ave flat sales value) for Oadby and Wigston is 4.8%, compared with 3.4% nationally.

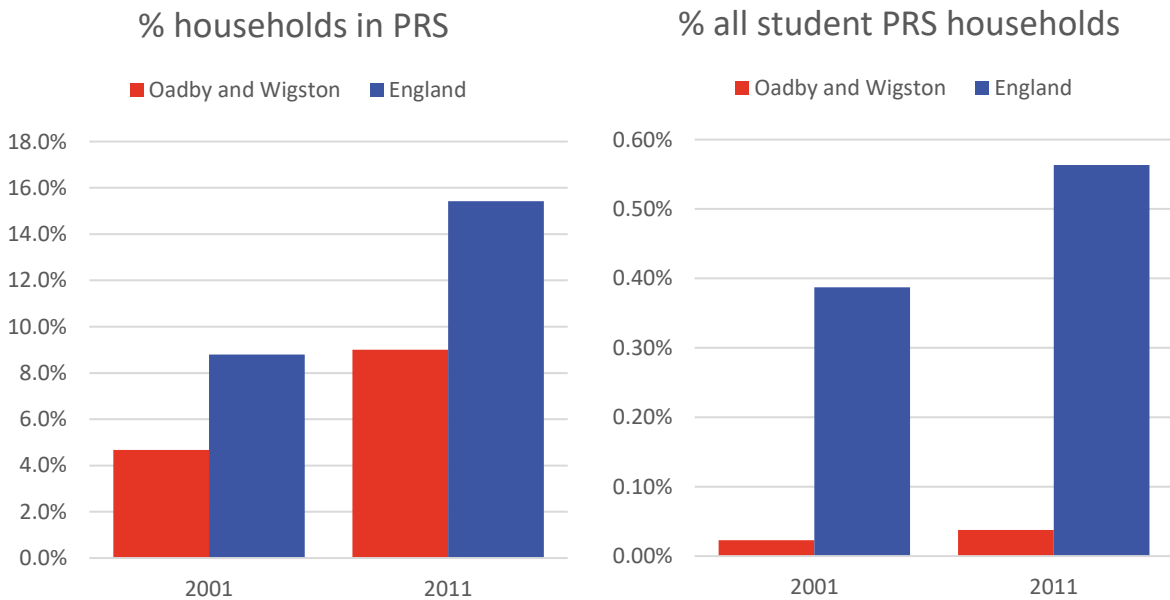
This chart shows the change in mortgage lending across the postcode districts in Oadby and Wigston. The total volume of lending in the 12 months to Q2 2018 was £2,103 million, compared with £2,118 million a year earlier, a change of -0.7%.

0.2% of residential properties in Oadby and Wigston were recorded as second homes in 2018 according to Council Tax Base data. This is significantly lower than the England average, suggesting high levels of second home ownership are unlikely to be a problem, though other sources should be considered.

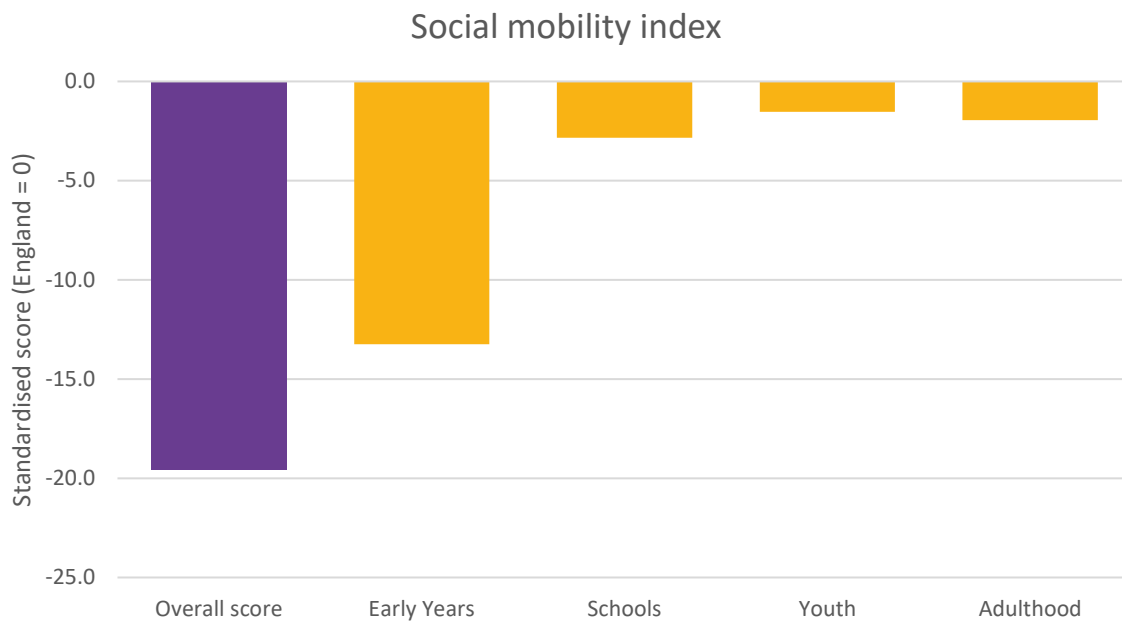

9.0% of households in Oadby and Wigston were rented privately according to the 2011 Census, compared to 4.7% in 2001. The England average changed from 8.8% to 15.4% over the same period.

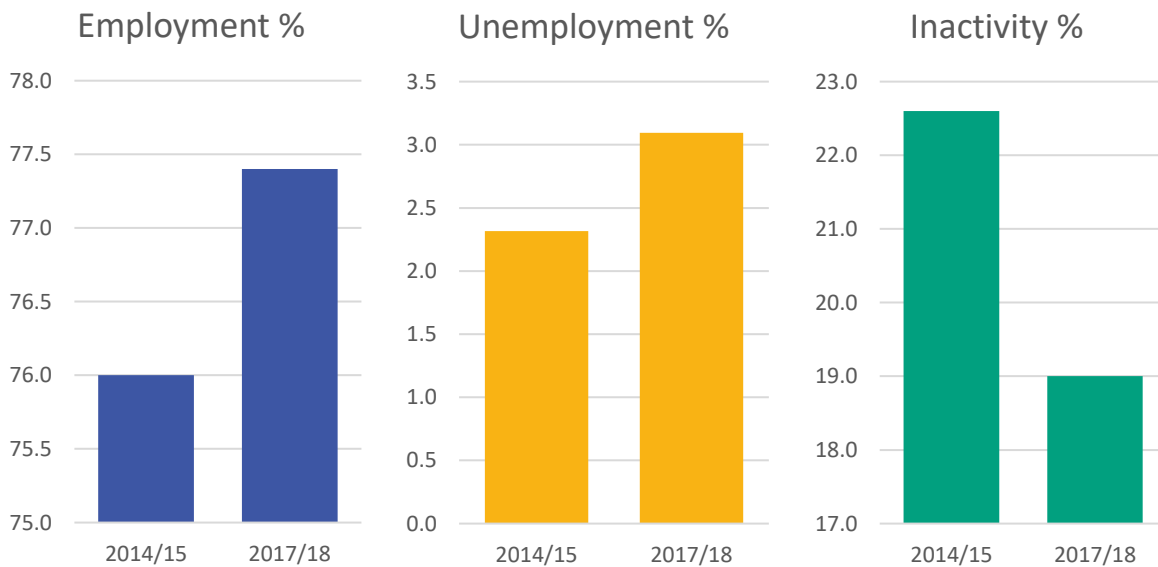
0.4% of the PRS households in Oadby and Wigston comprised only students in 2011, compared with 3.7% in England, suggesting students are not a significant part of the local PRS market.

Oadby and Wigston received an overall standardised score of -19.6 in the 2017 Social Mobility Index, compared to the England average of zero. Oadby and Wigston ranks as 236/324 for overall score across all English local authorities for which data is available. Local house price affordability could be a further barrier to social mobility in this area.

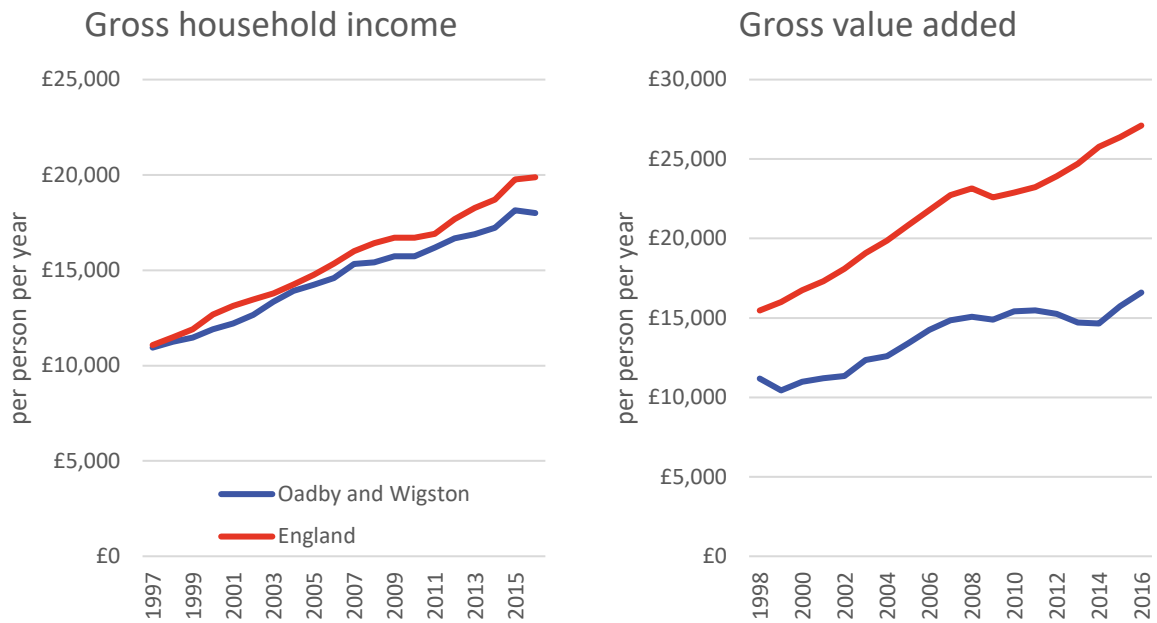

Employment in Oadby and Wigston changed from 76.0% in 2014/15 to 77.4% in 2017/18; unemployment changed from 2.3% to 3.1%; and economic inactivity changed from 22.6% to 19.0%.

By comparison, employment in England changed from 73.6% in 2014/15 to 75.3% in 2017/18; unemployment changed from 5.3% to 4.2%; and economic inactivity changed from 22.2% to 21.3%.

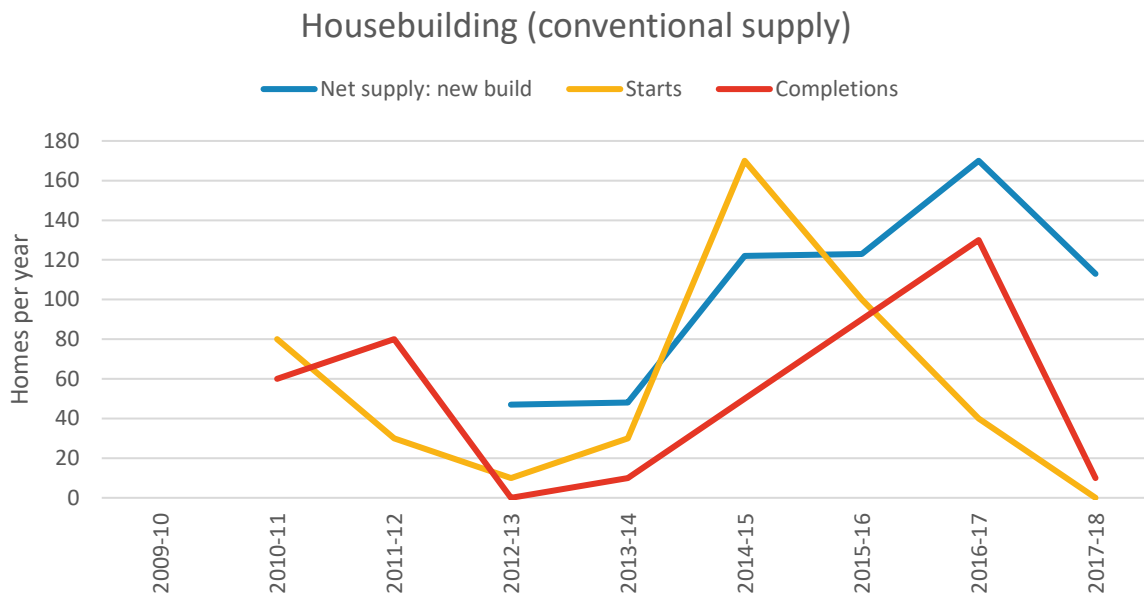

Gross domestic household income in Oadby and Wigston was £17,996 per person per year in 2016, compared with £14,596 in 2006. By comparison the figure for England changed from £15,349 to £19,878 over the same period. Based on this measure, Oadby and Wigston is an area of typical affluence.

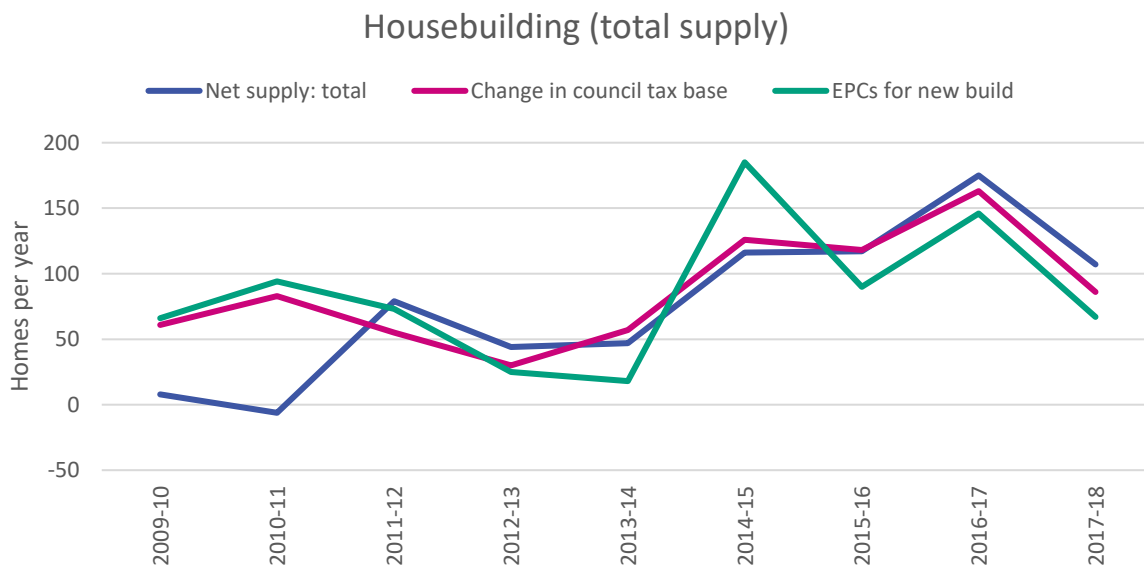
Gross value added at district level was £16,599 per person per year in 2016, compared with £14,249 a decade earlier. By comparison the figure for England changed from £21,773 to £27,108 over the same period.

The measures of 'conventional' housebuilding for Oadby and Wigston are shown in this chart. The 'official' MHCLG supply figures for 2017-18 recorded 113 new build completions (excluding any conversions or change of use). Over the same period 10 completions were recorded in the 'unofficial' quarterly data, along with 0 starts.

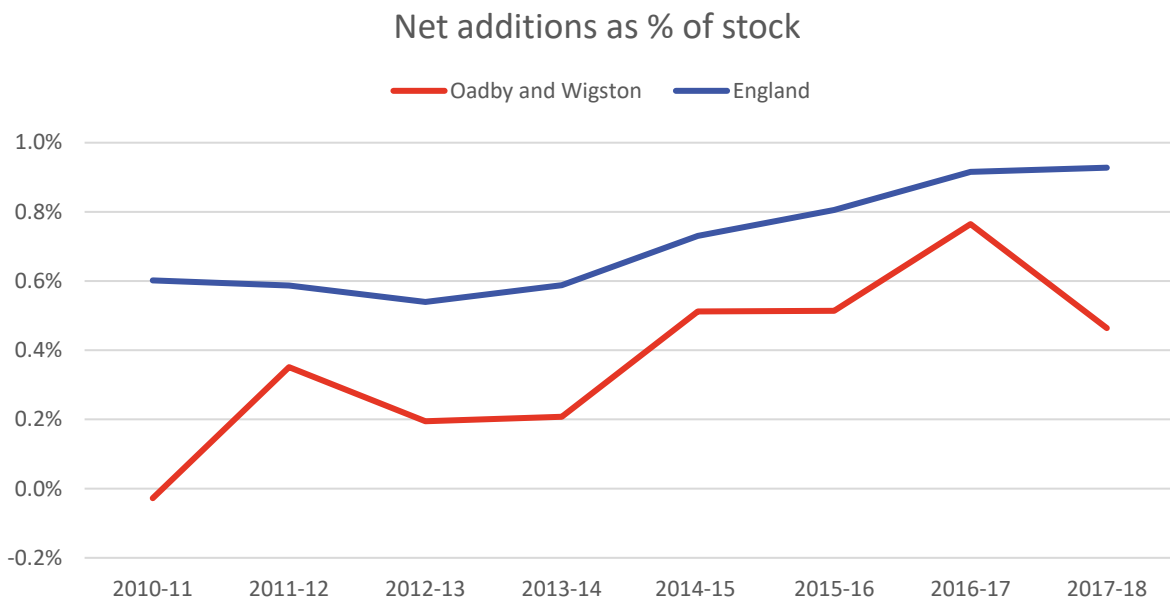

This chart shows total supply for Oadby and Wigston. The 'official' MHCLG supply figures for 2017-18 recorded 107 net new homes in total (including conversions and change of use, and after demolitions), and the Council Tax Base changed by +86 homes in the same period.

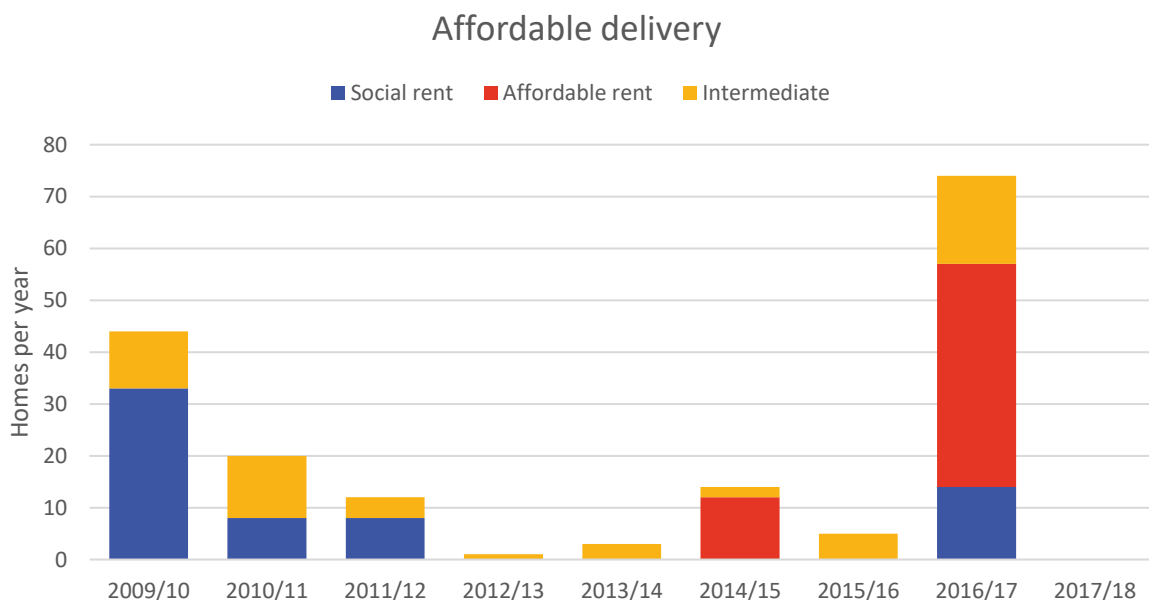
EPCs issued for new homes are used as a lead indicator of supply and can often be used to estimate net supply: 135 were recorded in the 2018 calendar year in Oadby and Wigston.

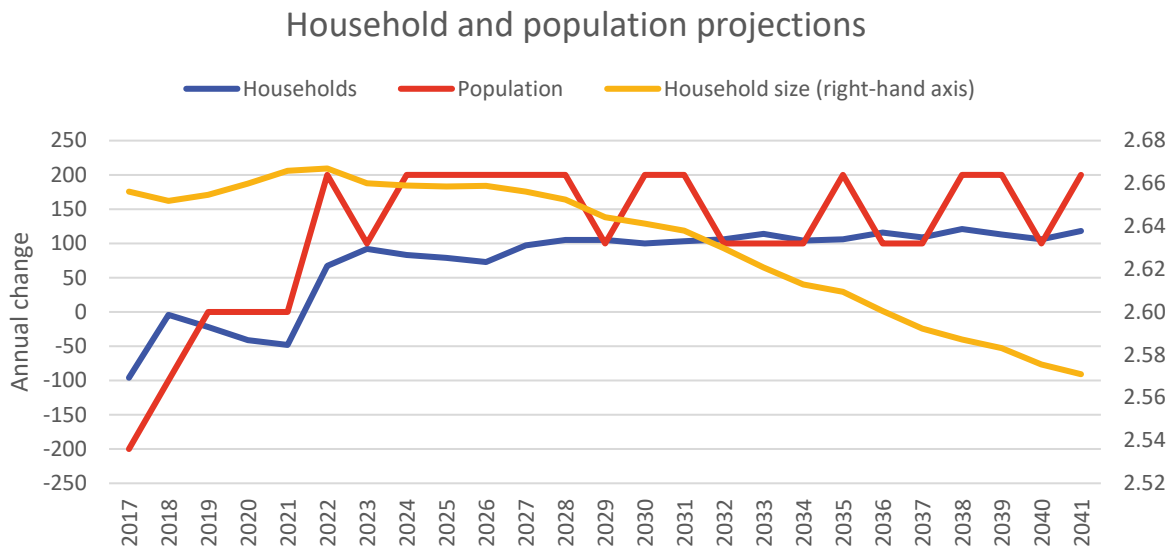
The net new supply in Oadby and Wigston increased the existing housing stock by 0.5% in 2017/18. This is much lower than the England average of 0.9%, suggesting the level of local supply is likely to be a significant issue. Note that the Government's national target of 300,000 homes per year is equivalent to 1.3%.

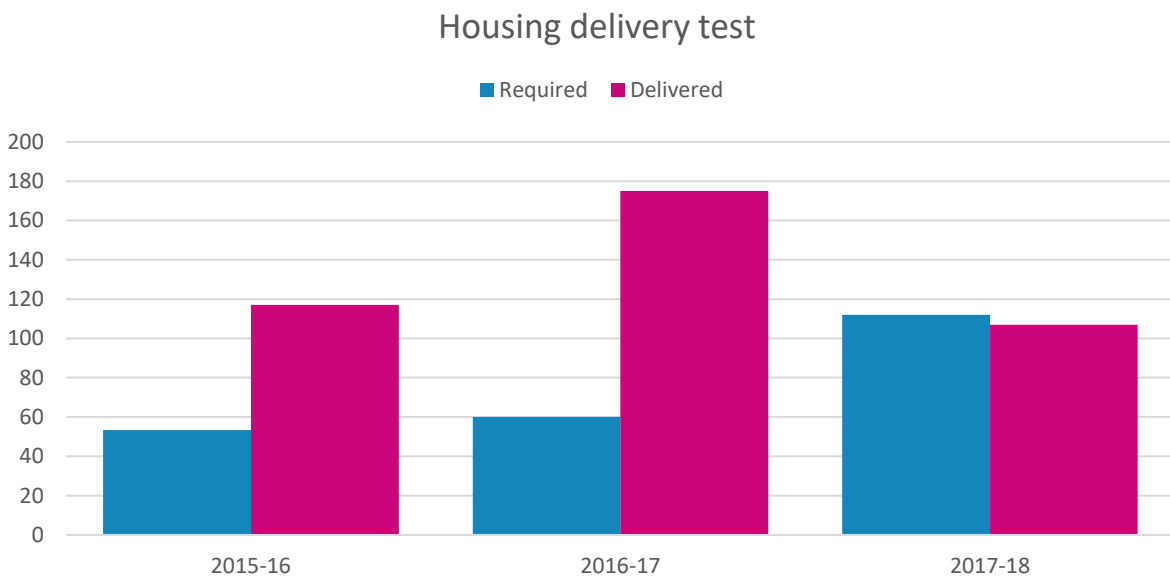
The previous analysis in this section covers delivery of all tenures / by all types of developer. This chart shows only delivery of affordable housing. In Oadby and Wigston 0 new affordable homes were completed in 2017/18: 0 for social rent, 0 for affordable rent and 0 intermediate affordable homes.

Population growth in Oadby and Wigston is set to average 145 people per year from 2020 to 2041, with projected average annual household growth of 88 households over the same period. The average household size in 2020 is projected to be 2.66, and 2.57 in 2041.

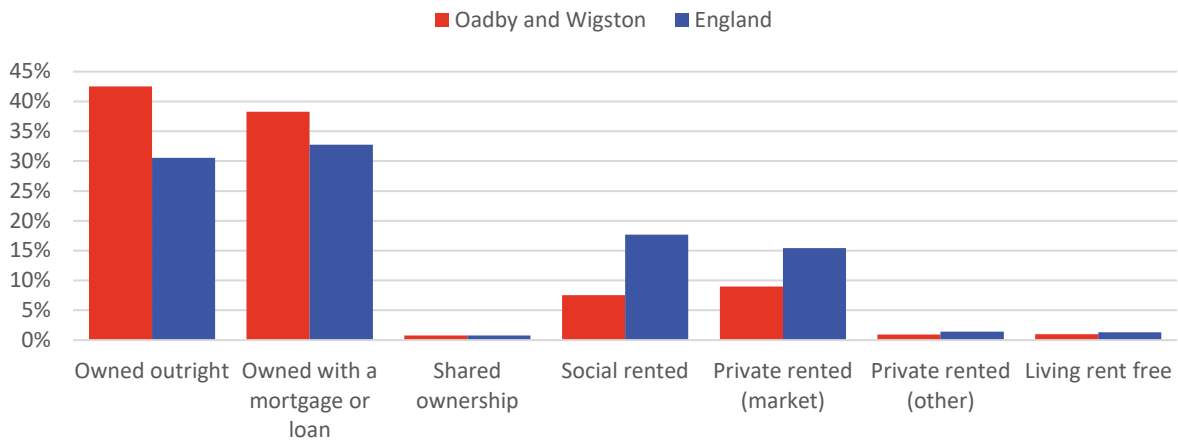

The most recent figures show that Oadby and Wigston delivered significantly more new homes than required by the MHCLG Housing Delivery Test. 399 net new homes were supplied over the past three full years, compared with the 225 required. The result of the test is that no action is required.

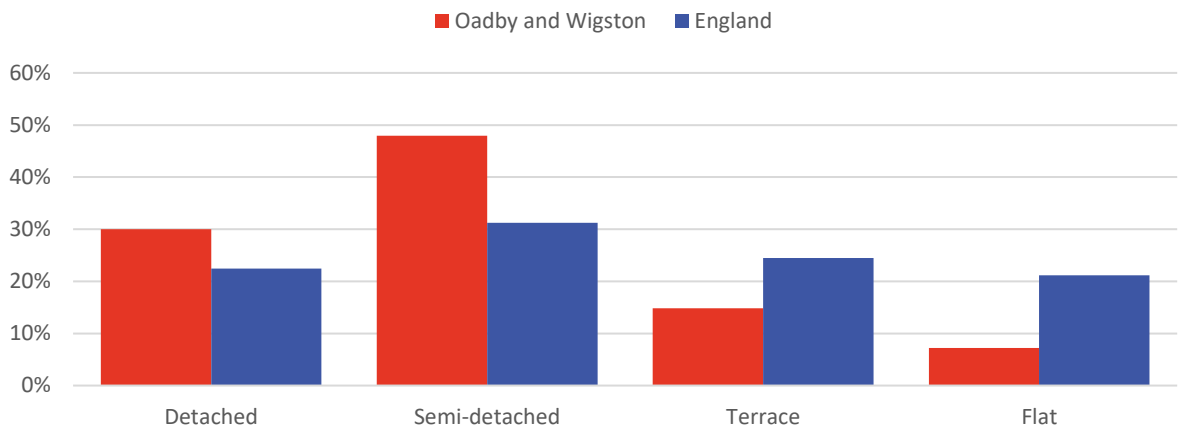

Tenure



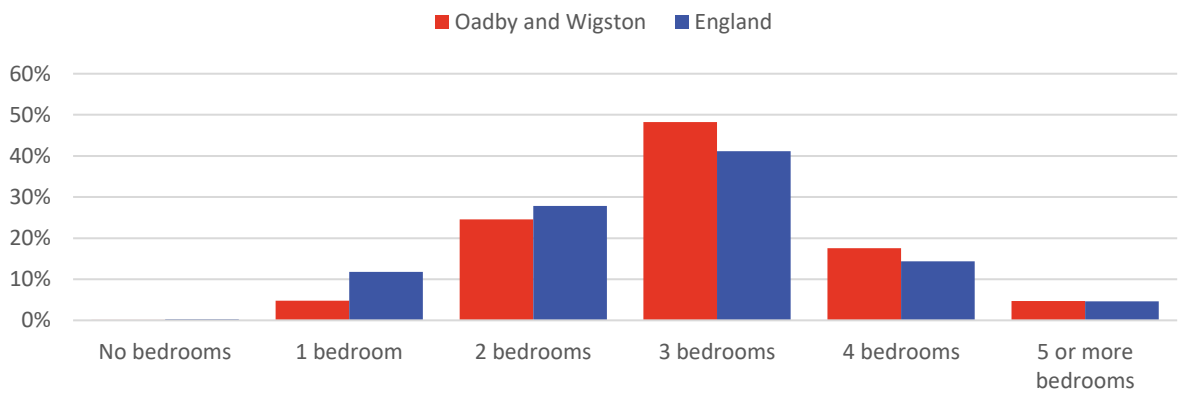

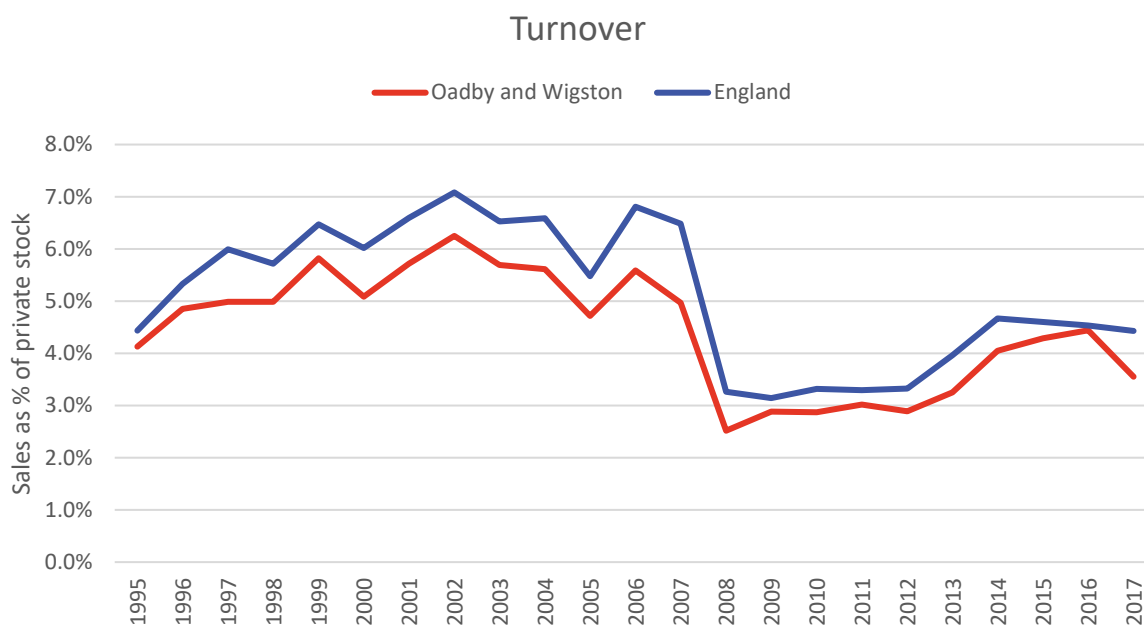
Number of bedrooms

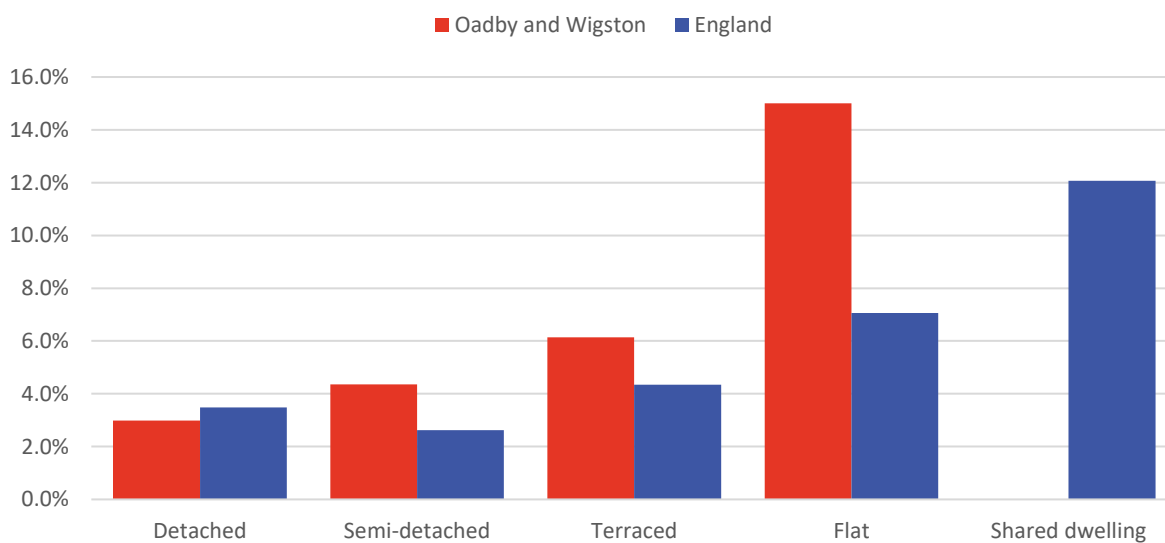

Turnover in Oadby and Wigston was 3.6% in 2017 (the latest year with full data). This is significantly lower than the average before the global financial crisis (turnover from 2001-05 averaged 5.6%). For comparison turnover in England was 4.4% in 2017.

Note that the above analysis includes both standard Land Registry 'A' data and additional 'B' data (which covers repossessions, mortgaged buy-to-let and corporate transactions). In Oadby and Wigston in 2017 there were 61 'B' sales, 8.1% of the total.

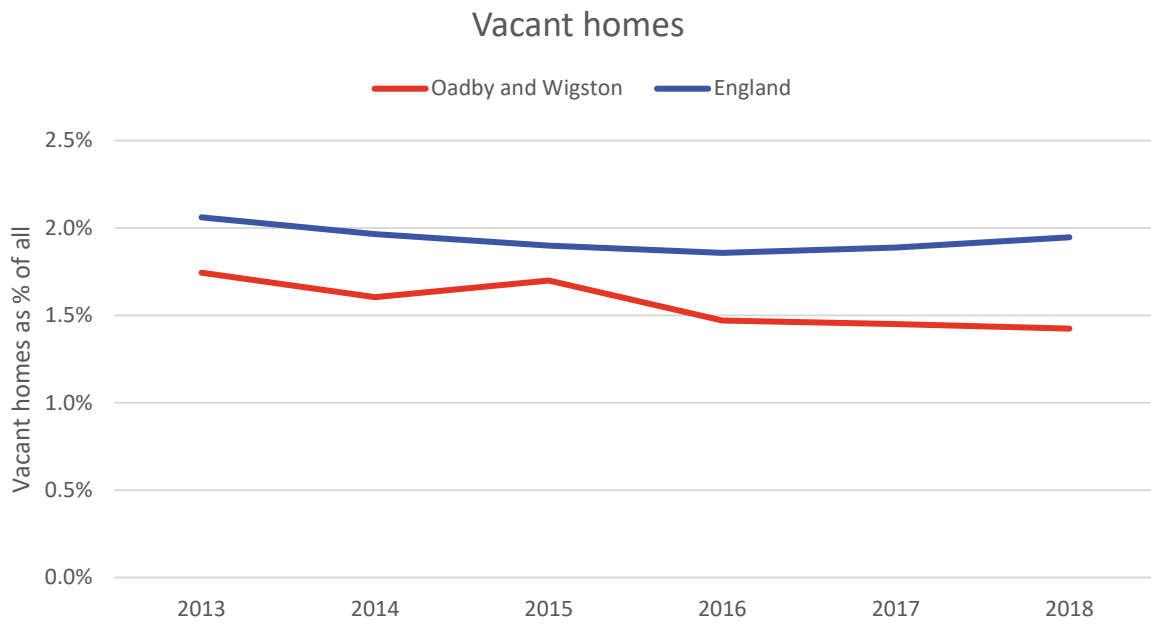
Homes with no usual residents

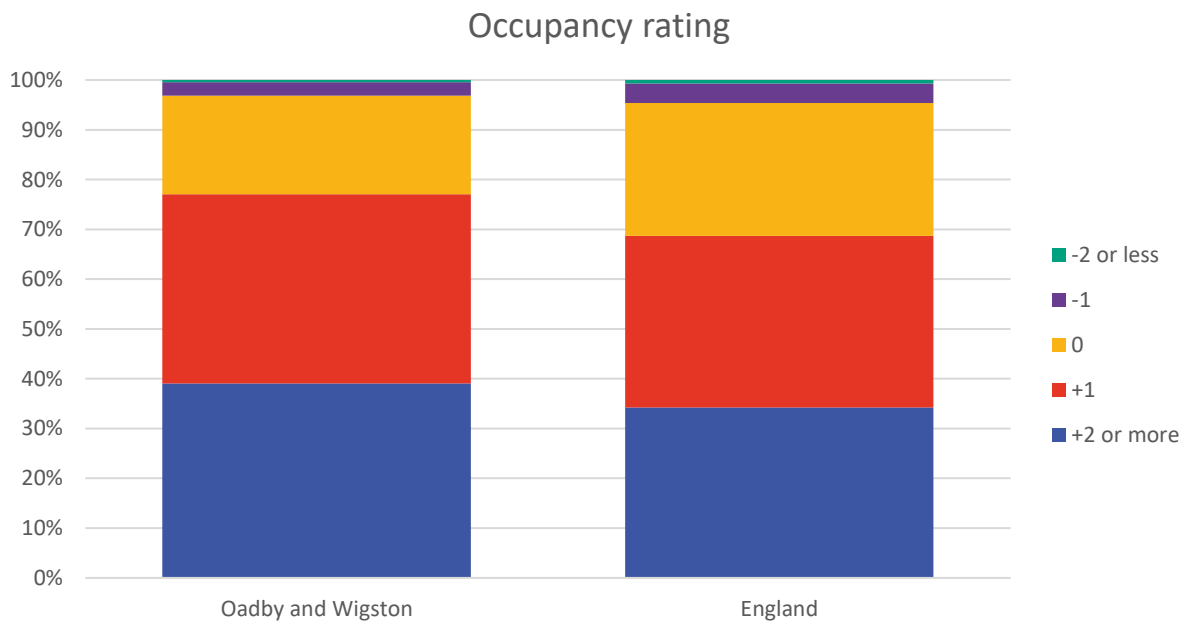
The proportion of homes with no usual residents in Oadby and Wigston was 5.1% according to the 2011 Census. This level is higher than the England average of 4.3%.

1.4% of residential properties in Oadby and Wigston were recorded as vacant in 2018 according to Council Tax Base data. This is lower than the England average, suggesting high levels of vacant homes are unlikely to be a significant problem.

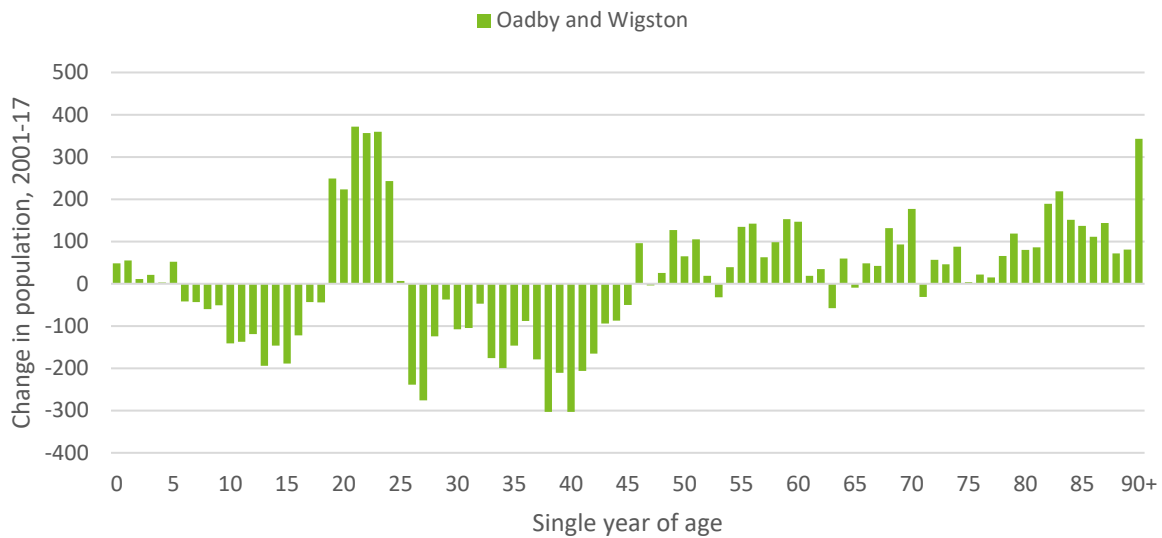

39.1% of homes in Oadby and Wigston had two or more spare bedroom, according to the 2011 Census. This is higher than the England average, suggesting the distribution of housing is likely to be a problem.

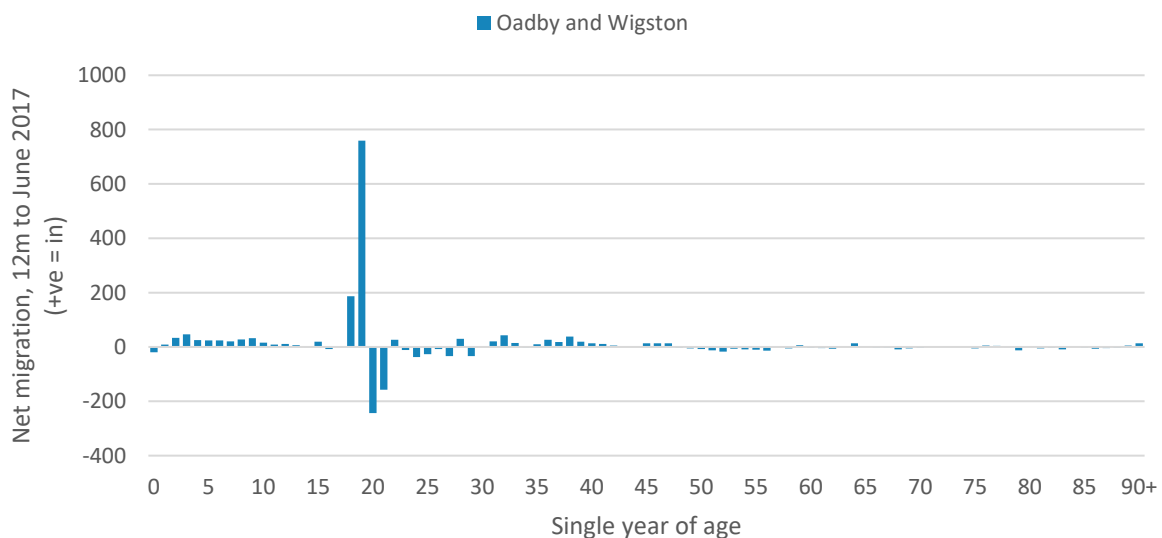
Population change by age, 2001-17

Overall, the population of Oadby and Wigston grew between 2001 and 2017, changing by +2.2%. Overall growth at national level over the same period was +12.5%. By age, the largest single contribution to growth was from 21 year olds.

Net migration by age

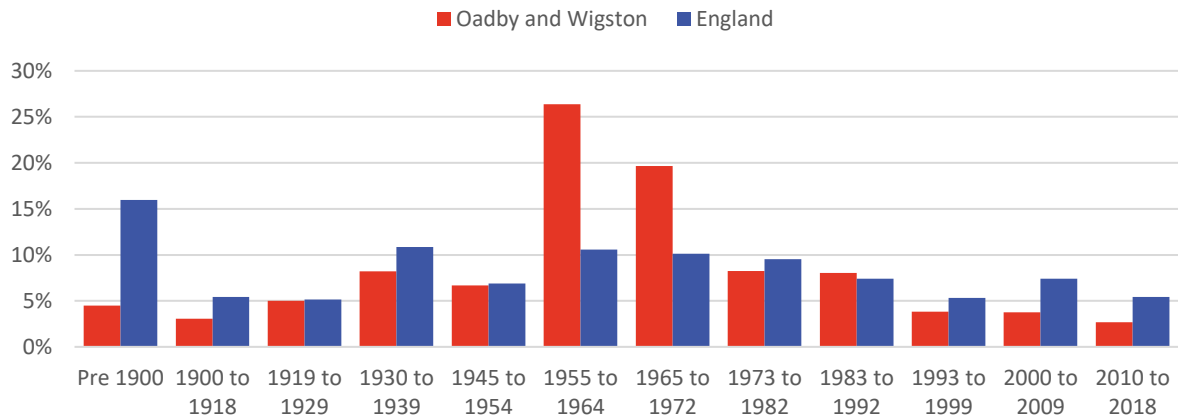

The overall population in Oadby and Wigston changed by +1.8% due to migration in the 12 months to June 2017: +1.5% from domestic sources and +0.3% from international. By age, the largest single contribution to growth was from 19 year olds.

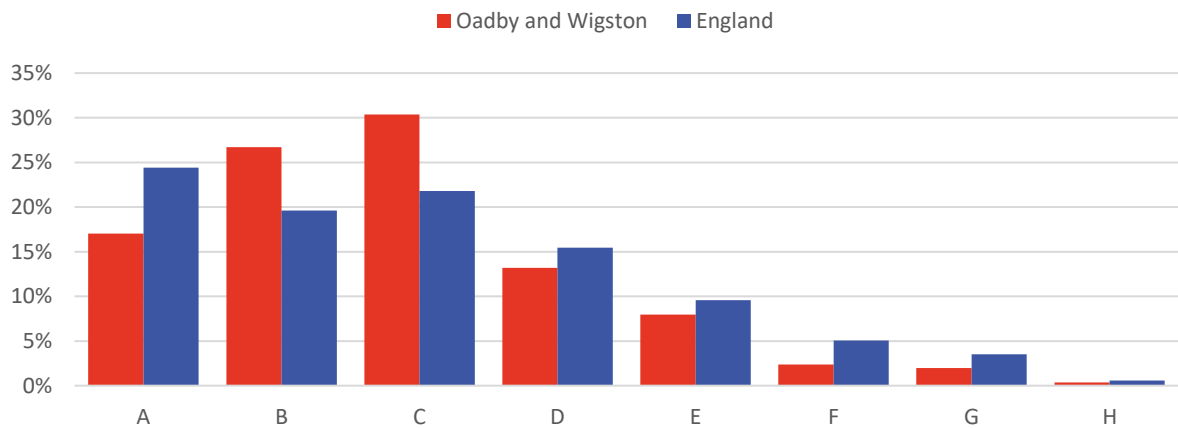

Age of housing stock



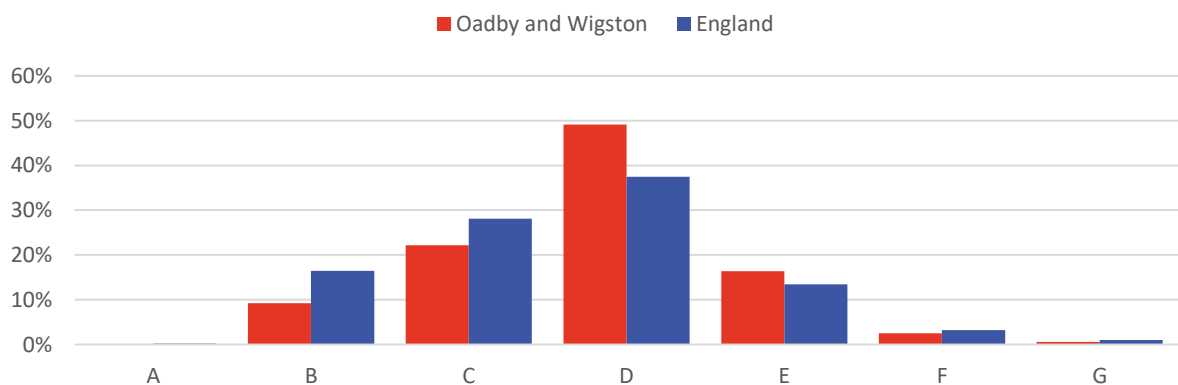

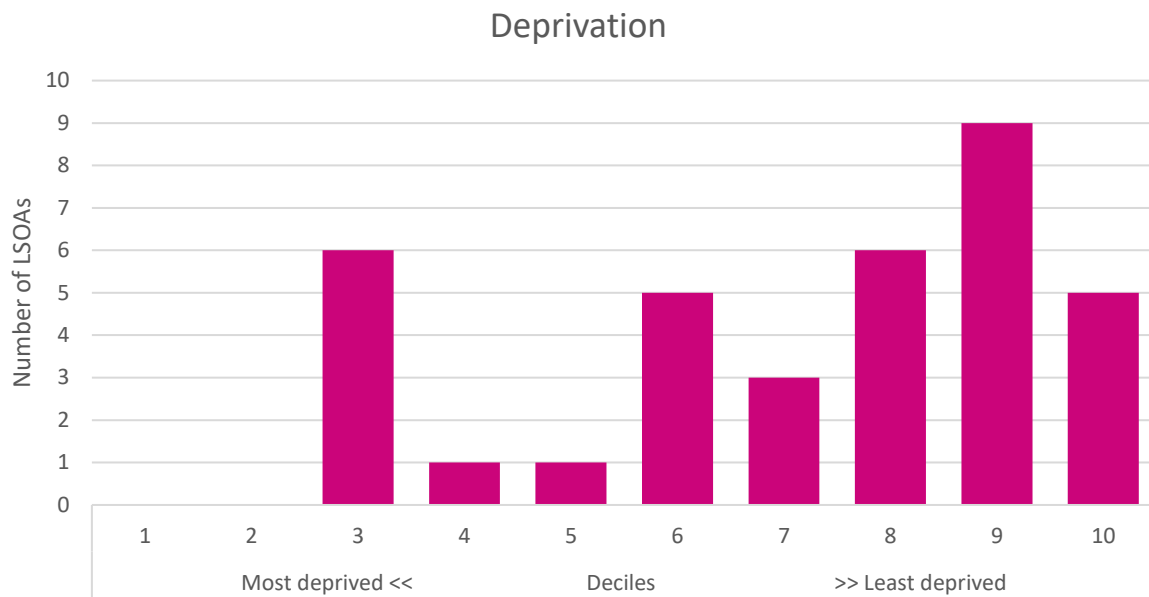
EPC rating

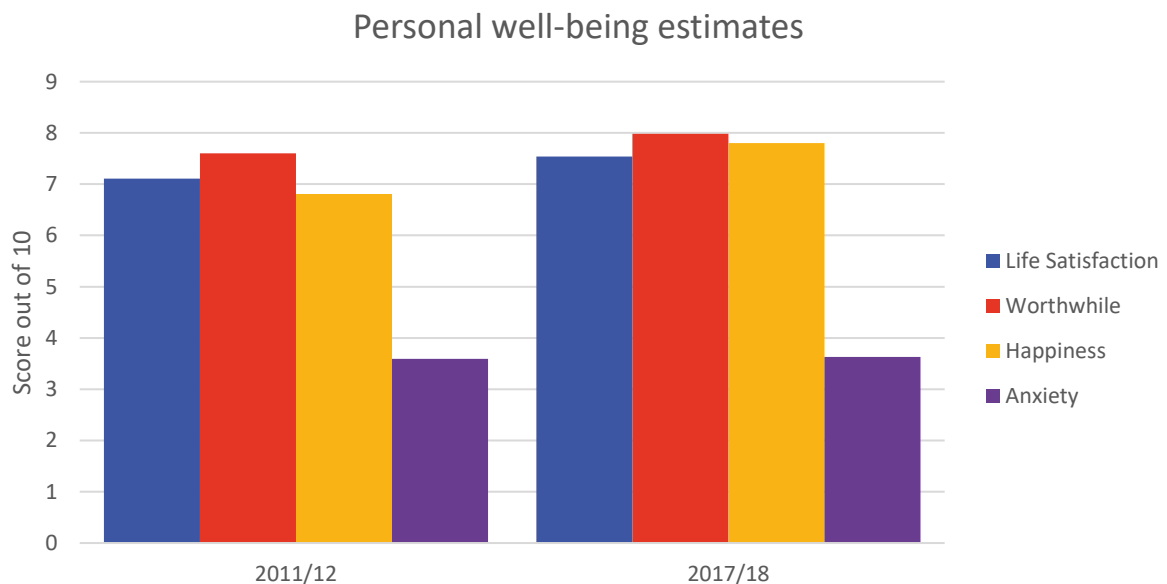
These three charts show property characteristics for Oadby and Wigston from the 2018 Council Tax Base, compared to the national averages.

17% of the LSOAs in Oadby and Wigston are in the three most deprived deciles, based on the 2015 indices of multiple deprivation. This suggests it is an area of low relative deprivation (the national average is 30%).



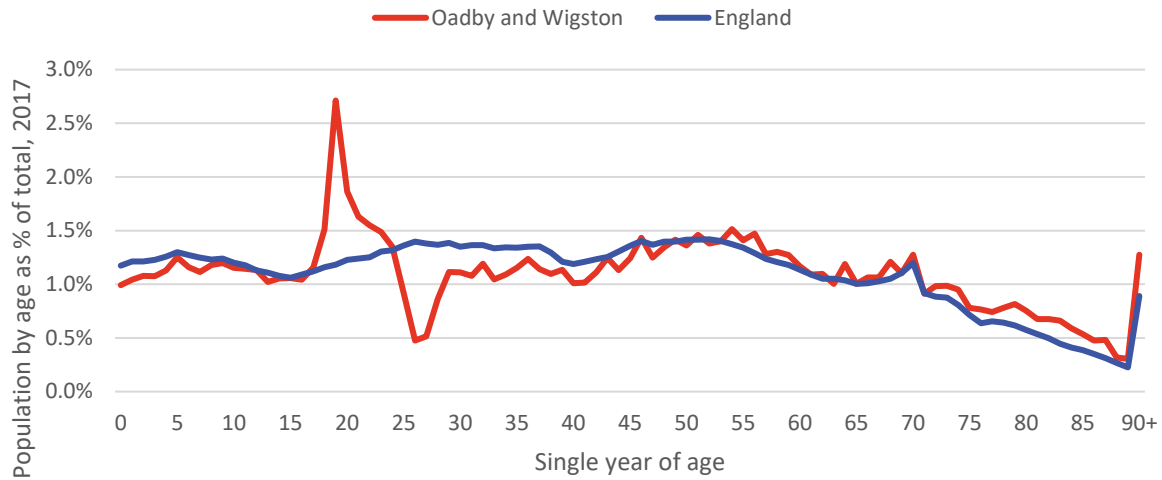

Residents of Oadby and Wigston scored their life satisfaction at 7.54 out of 10 on average in 2017/18, compared to the England average of 7.68. The corresponding figures for 2011/12 were 7.11 and 7.41 respectively.

Over all four categories combined, local people have lower than average levels of well-being in 2017/18, compared to the national figures.

Population structure

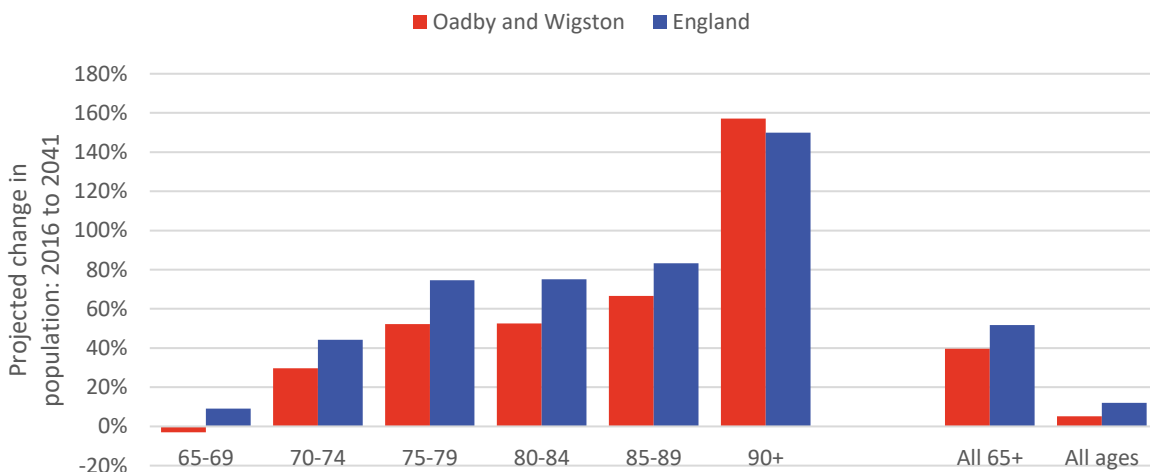

The population structure of Oadby and Wigston comprised 12.1% aged 18 to 24, 46.7% aged 25 to 64, and 21.2% aged 65 and over in 2017. The corresponding figures for England were 8.7%, 51.9% and 18.0%.

This suggests that the local population may include a higher than average level of students, along with a higher than average level of older people.

Population growth: older people

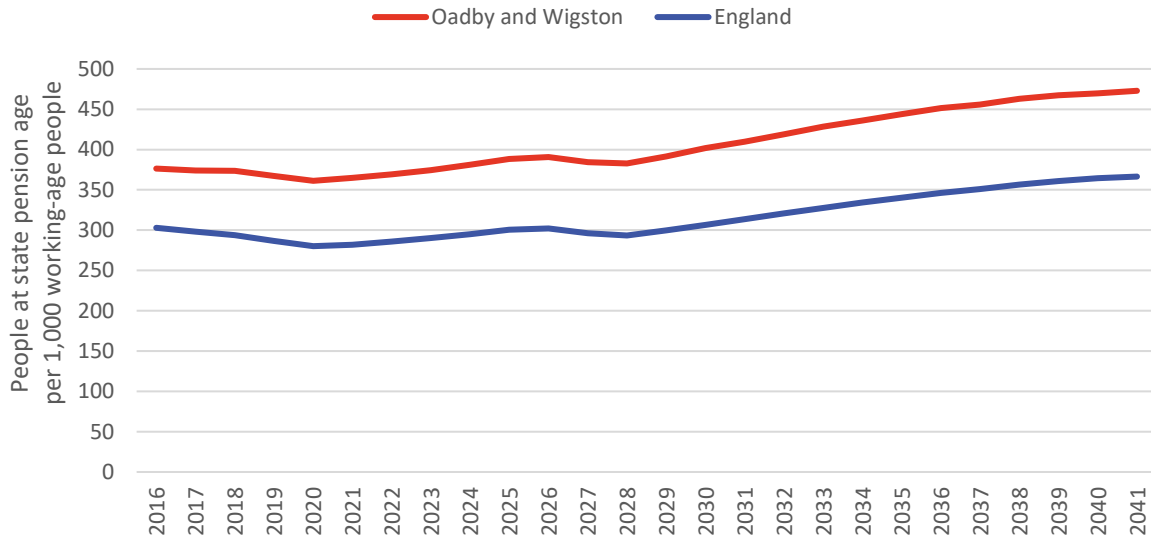

The 65 and over population of Oadby and Wigston is expected to grow by 39.7% from 2017 to 2041, according to the latest ONS population projections. This is compared to an overall population change of +5.2%. The corresponding national figures are growth of 51.7% and 12.1% respectively.

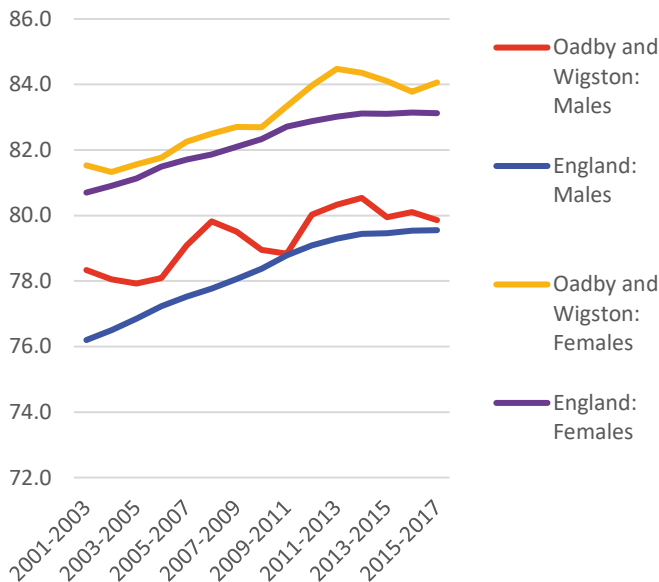
Old age dependency ratio



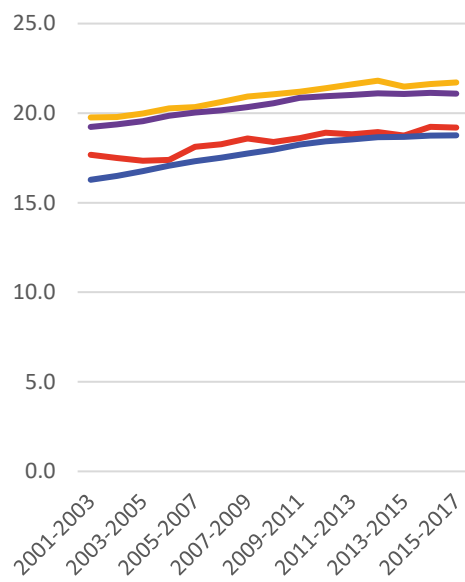

In Oadby and Wigston in 2019 there are expected to be 367.2 people of state pension age for every 1,000 working-age people, compared to an average of 286.8 at national level. By 2041 these rates are projected to reach 472.9 and 366.4 respectively.

Life expectancy at birth



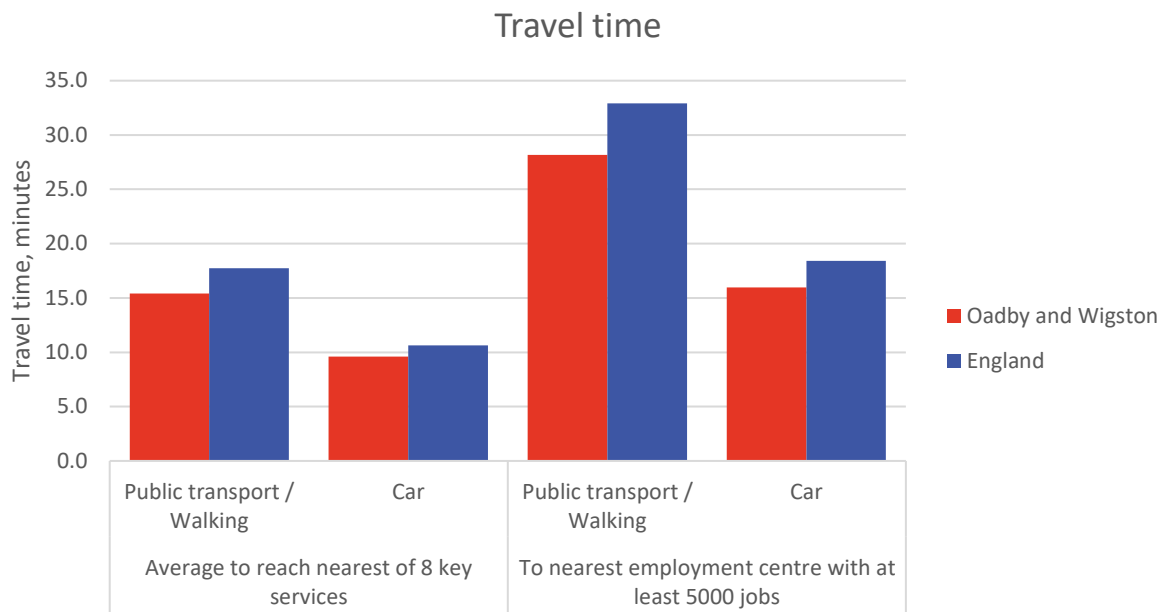
Life expectancy at age 65

The average life expectancy for people born in 2015-17 in Oadby and Wigston is 79.9 years for men and 84.1 years for women. The equivalent national figures are 79.6 and 83.1 respectively.

Oadby and Wigston has above average public transport connectivity compared to the national figures, with an average travel time to reach the nearest 8 key services of 15.4 minutes (England average = 17.7).
